# Group Representative Rollcall at the Business Meeting.

In the past at all assemblies (nonelection and election assemblies) we have verbally called roll from the sign in sheets. This is an opportunity for every GR to say "present" and have voiced that they are representing their group. At the last business meeting it was a non-election business meeting so we had the District Representatives (DRs) take their district's roll and report the number and people to the secretary. # <u>Delegate Report ~ Joyce Y.~</u>

Have you seen the 2015 World Service Conference Summary – Living our Spiritual Principles – Expanding Our Vision? The Conference Summary can be read online or downloaded from the members website at

http://al-anon.org/members/pdf/summary/

<u>summary 2015.pdf</u>. A hard copy of the summary (P-46) can also be purchased from World Service Office for \$5.00.

#### Points of Interest in the Summary:

- Page 38-42: Vision for Service Leadership and program attraction
- Page 54-59: Memorial Contribution Discussions Conference members were asked for their input, insights, thoughts, and serious consideration of the matter with spiritual principles at work through the discussions. The Conference requested the Policy Committee to work on preparing language regarding a one-time memorial contribution. The Conference can then review again to assure what is the best interest of Al-Anon as a whole.
- Page 45-48: Is the current model of Alateen the best model for the future of both Al-Anon and Alateen? In some Areas, what is stopping our kids from coming to Alateen? (Due to concerns that some members may have misunderstood the discussion, the July 2015 Chairperson of the Board letter stated "The focus was on finding ways to encourage more attendance and participation by teens to ensure the future of Alateen. ....Hence, the conversation began at Conference and continues at each Board meeting until we figure out the right questions to ask and receive specific guidance from the teens.")
- Page 73-75: Abundance and Spirituality Many financial discussions in the past have centered on lack and scarcity rather than abundance. This year the Conference was asked how can the spiritual side of the program be applied and a look at finances through Spiritual Abundance? Several strategies were presented to overcome some of the barriers of money discussions by showing the importance of abundance and spiritual principles in financial conversations.

## Did you know?

- Reminder about Quarterly Appeal Letter from WSO as stated in 2014-2017 Al-Anon/Alateen Service Manual (P24/27), Pg 58. It is an opportunity for individual members to participate in Twelfth Step work beyond the group level. "..... an opportunity for members to contribute in gratitude for what Al-Anon/Alateen has given them......"
- Under "Passing the Basket" groups are encouraged to read the entire quoted section from Page 23 of the 2014-2017 Service Manual in your meeting. In part it encourages members "to contribute in gratitude for what Al-Anon/Alateen has given us."

On a personal reflection, Spiritual Abundance is a way of expressing my gratitude for the principles of living so freely given to me and to assure it will be here for those who will need it in the future. How can Spiritual Abundance be applied to other areas of the program such as Participation (Concept 4), Communication, Service and Leadership (Concept 9)?

# <u>Alt. Delegate/Literature/Forum Coordinator</u> <u>~ Margaret F. ~</u>

Hello Texas East Area 53 Al-Anons and Alateens!

I thought it might be helpful to provide you with some talking points/interesting facts for your Forum report.

- From the Al-Anon/Alateen Service Manual, p. 104, "*The Forum* can be used, and is encouraged to be used, by all members and groups for meetings. *The Forum*, as a concept is Conference Approved..."
- The magazine does not generate any income. The subscription cost pays for printing and postage – it does not cover the cost for staff resources to process submissions, develop the content, and design the magazine.
- Subscriptions are basically holding around 20,000 down by approximately 4,000 since 2010. Currently, there is still, on average, only 1.4 subscriptions per group. The latest subscription report is in the "Subscription Reports" folder on e-Communities. Check it out to see how many subscriptions there are in your State or Province.
- Portions of the magazine are translated into Spanish and French for inclusion in en acción and Le lien.

Texas has, as of March 2015, six hundred one (601) groups and subscribes to 863 Forums which is up by 12 subscriptions from December 2014. Have you ever thought about giving your Al-Anon friends a subscription for their Al-Anon birthday or ordering an extra copy to give to new comers?

The new daily reader hopes to include sharings that represent the fellowship as it is today. How can I help more members submit writings that reflect the inclusiveness of our program? The Associate Director of Communications—Literature said this can be challenging, because since our books don't include the names of those who write, it can be difficult to know if a man or a woman wrote the story. Diversity is not always evident in most of the sharings received so far. A coordinator suggested encouraging writers to include more descriptive information about themselves in their writings. For example, they could start the sharing with, "I'm a young man from Nebraska...," or "As a grandparent of an alcoholic....", and then share how they use the program in these particular situations. The hope is that the daily reader will let members who feel alone and isolated know that they do belong.

Writing Workshop Guideline for New Daily Reader, is intended to help members write thoughtful meditations that are in keeping with the intended spirit of the project. By the way, the daily reader writing guideline was included as an insert in every copy of the July issue of *The Forum*. Please encourage members to use it. **Intimacy piece update:** We have received over 1,140 sharings, but can still use more.


Also, we are now accepting proposals by Al-Anon members who are experienced, professional freelance writer/ editors who are interested in working on this new piece of literature in development.

Submission deadline is October 15, 2015.

**Parents & grandparents pamphlet:** WSO has received over 150 sharings, but need many more—especially about how parents and grandparents apply the Twelve Steps to the specific situation of being affected by a young person with a drinking problem. WSO is also looking for Al-Anon members who are experienced, professional freelance writer/editors to submit proposals for this pamphlet. Interested, qualified members can find further information on the Members' Web site by following the steps listed above.

**"CAL Corner**": September's "CAL Corner" articles in *The Forum* focus on how *Discovering Choices* (B-30) has helped members in their recovery. The October articles will be about *So You Love an Alcoholic* (P-14).

**CAL Sample Chapter:** Each quarter we post a sample chapter of Conference Approved Literature on the Members' site, www.al-anon.org/members. ## Public Outreach ~ Judy W. ~

There is a lot of great work going on within our East Texas Area District Public Outreach Coordinators (DPOCs). We have 12 active districts and 13 DPOCs.

#### Area Summary Highlights:

• Public Service Announcements (PSAs) by the Area Coordinator were distributed so that "Thank You" District campaigns could be initiated to the local radio and TV stations.

- Five districts reported activity in working with churches and various health fairs.
- Four districts are involved with Alateen related activities.

• Three districts have started or are continuing to work with treatment centers.

• Two districts reported using the *Al-Anon Faces Alcoholism* literature in their districts.

Two districts are working with the judicial system.

## DPOC Cool Shout Outs:

- District 6 (South) has discovered that 2 person panels are working well in their monthly treatment center visits.
- District 7 is organizing an "Uncle Al(-Anon) Wants You" campaign to get volunteers involved in various public outreach activities.
- District 2 found contacts for sharing their Alateen flyers at the regional Independent School Districts.

• District 12 gave public outreach workshops to eight groups.

• District 4 shared "Al-Anon and Alateen Role in Recovery" CD (AV-31) at a treatment center.

• District 10 had two Alateen sponsors participate in a college service health fair.

We will continue our networking events at the next Fall Assembly in San Antonio. Hope to see everyone there!

**GREETINGS TO ALL AREA 53 MEMBERS** 

Not much to report right now. Things slowed down after the annual recertification in June and I took advantage of the extra time to work on the Alateen files, reviewing and updating them, as well as shredding some of the old documents. Not done yet, it's not an easy task! This is an ongoing process.

As I mentioned in my 3<sup>rd</sup> quarter report, our Area ended with **84 AMIAS and 26 Alateen Groups after recertification.** Number of AMIAS remains the same but we now **have 24 Alateen Groups.** 

AMIAS Certification is done year-round. Anyone interested in serving as an Alateen sponsor must participate in AMIAS Sponsor Training prior to submitting their application. Training is required for the first two consecutive years and every three years thereafter during continuous service as an Alateen Sponsor. Once you meet this requirement, you may proceed to fill out the 3 page certification application which consists of the following forms. These can be found on our Texas website:

- **1. AMIAS Registration Form**
- 2. Criminal Record Release Authorization
- 3. Al-Anon Member Involved in Alateen Service.

Please read the instructions carefully to ensure you meet all of the Safety and Behavioral Requirements before submitting it.

By year's end, I will be notifying everyone personally, of the training needs in order to recertify next year. If you don't hear from me, please contact me. Love in Alateen service.







#### <u>~ Inside Al-Anon Family Groups ~</u> By Claire R.

#### Anonymity—Our spiritual foundation and me

This short "quiz" is the first of a three-part series for members to reflect upon the principle of anonymity. It is an opportunity to assess my understanding of anonymity and how I apply this spiritual principle to my recovery—--within and outside of our fellowship.

This first article is about personal anonymity. The second and third article encompass anonymity within and outside of our fellowship.

As Tradition Twelve says, "Anonymity is the spiritual foundation of all our Traditions..." But this principal can be misunderstood. As our cofounder, Lois W. states on page 194, in her *Lois Remembers* (B-7) memoir, "Let us not mistake anonymity for secrecy."

#### Personal anonymity—My comfort zone

Some Al-Anon members prefer to maintain a higher degree of anonymity that others do. We respect the personal decisions of others, without judging them and without fear of being judged.

Over time, I might change my mind about the degree of anonymity that I choose to maintain. The real issue is my personal "comfort zone" with anonymity.

The number of "never," "seldom," "usually," and "always" responses can tell me a lot about myself and my personal need for anonymity. It is only a measure of where I am today. If I am growing in my recovery, my point of view may change.

#### **Reflections:**

How much anonymity do I really need among people I know (outside of meetings)?

If I am still keeping my Al-Anon membership a secret from family, friends, and people I know (non-members), what am I trying to hide from them?

# East Texas Al-Anon/Alateen AWSC Minutes September 19, 2015 Smithville, Texas

**3.** Pat E. moved that the Assembly Guidelines be accepted as updated. Motion passed.


# AWSC REOMMENDATION
