# <u>Delegate Report ~ Joyce Y.~</u>

Spring flowers and beautiful sunrises over the Atlantic brought joy and serenity for "**Realizing Our Spiritual Potential**" during the 56<sup>th</sup> World Service Conference in April, 2016. At the beginning of the conference, Board Chair Paula B shared Ric B. is no longer with the World Service Office. WSO under his leadership was an era of moving from New York, blending New York and local talent, creating a strong, skilled and diverse workforce. If any of you would like to send expressions of gratitude for his service, you may do so through the WSO and these will be forwarded to him.

Moving forward into World Service Office's next exciting chapter resulted in some changes to WSO organizational structure for increased communication between departments and streamline activities. Mary G., Past Trustee, will serve as interim Executive Director for a period of time to ensure the Director of new office structure is functioning well. Programs will be responsible for participating in the development, implementation, and evaluation of all World Service Office activities that serve members and potential members. e-Platforms Manager will oversee all aspects of technology and innovation to expand services and products to the fellowship, professionals, and the general public. Position descriptions are being finalized and will be posted on the Member's Web site at http://al-anon.org/members, click on WSO tab, then click on Employment Opportunities.

Check out the **2016 Annual Conference Summary (**which will be available late summer on members website as well as hard copy of summary) for more complete details and discussions. Here are some highlights:

**Financial:** Average cost of services per group is \$268.12. USA/Canada Total Groups is 15,237, and only 51.75% contributed to WSO for an average of \$119.52 per group. In Texas East the 54.6% of groups contributed an average of \$148.49. Breakout sessions were held during the conference to provide a better understanding of financials. One member stated "Healthy relationships discuss finances."

**Public Outreach:** The Al-Anon Public Service Announcement (PSA) was in the top 1% of all PSAs in 2015. It was shown 8500 times for 80 million viewers. Please express Thank you to stations playing the PSAs In your community. There have been 1,100,000 hits so far with likes on Facebook. The new PSAs - Parents of Young People Affected by Someone's Drinking and Children of Drinking Parents, will be available for release in May. Closed Caption PSAs are available for use in airports and restaurants.

**Literature:** The trial period for the CAL calendar quotations has ended and the project now continues on an ongoing basis. 20 quotes per year are available from WSO. Because groups are no longer receiving complimentary copies of *The Forum*, the June Group e-News will include a link to the "News from the 2016 World Service Conference" report that will be posted on the Members' site. The July and August issues of *The Forum* will have a full-page ad detailing where to find the report as well. Placing it on the Web site makes it more accessible (In previous years, this report was included in the July and August issues of *The Forum*.)

Alateen: There were continued conversations related to the

current model of Alateen, and results of the recent Alateen survey were shared. The focus continues on securing ways to encourage participation of teens. One interesting result of the Alateen survey centered on the use of technology. The Alateen members participating in the survey overwhelmingly shared that technology is of no interest. The shared preference was face-to-face meetings.

Task Forces: Four Task Forces were presented: Anonymity and Technology; Communication and Strengthening our Links of Service; Meeting Types; and Acceptance of Communities, Cultures, and Beliefs. One member shared how she realized she had limited herself in reaching her own spiritual potential through the presence of preconceived ideas. All four presentations were powerful and worthy of use in our Areas. These will be shared more at future assemblies and when visiting districts.

**Concept 11:** Conference members approved amendments to the descriptive text of Concept Eleven on pages 207-214 in the 2014-2017 Al-Anon/Alateen Service Manual (P-24/27) to allow for updates reflecting various structure changes of Standing Committees, as well as the addition of Thought and Task Forces and Work Groups, while keeping in mind that Al-Anon is a worldwide fellowship and that not all International structures have made the same changes.

**Memorial Fund:** The Conference approved language regarding a limited, one-time memorial contribution in memory of deceased Al-Anon members, by family members who are not Al-Anon members. This language was requested by the 2015 WSC. The Service Manual will be updated to reflect this change.

**Meet the Board:** The next Meet the Board will be held on October 22, 2016 at The Chancellor Hotel, 70 North East Avenue, Fayetteville, AR 72701. Registration is \$30 and includes lunch (*gourmet sandwiches/wraps, salad and dessert*) and afternoon snack. This sounds like a great service road trip and an opportunity to see how it works. The three year trial period for Meet the Board has been extended to 2017-2019. Our AWSC talked about possibly putting in a bid for one in East Texas. More details will be provided to the AWSC on the bidding process for further review and discussion. Dates for 2017 Meet the Board is October 21, 2017. Bids must be submitted by September 16, 2016.

As of May 16, 2016 – Do you know what is happening in 2 years, 1 month, 18 days??? Have you figured it out yet??? That will be Al-Anon's 6<sup>th</sup> International Convention - Baltimore, Maryland - July 6-8, 2018. Let's show Maryland that Texas East Al-Anon is alive and well with a huge attendance from our area. This is an awesome opportunity to meet and share with members worldwide. Also the announcement to begin planning for the **2023 International Convention was made**. Detailed information outlining the bid process, meeting and hotel room requirements, and all the information needed for presenting a bid were handed out to each Conference member. Our AWSC discussed and will be looking at two possible locations and bring back information to the next AWSC to determine if Texas East would like to make a bid by the December 1, 2016

#### GREETINGS FROM YOUR AAPP

AMIAS Recertification 2016 is not going very well this year. There has been a huge delay in getting AMIAS applications in a timely manner. Thinking that the storms and flooding situation in East Texas had something due with the delay. I extended the deadline from June 1, to June 7th. As I write this, I still have at least a dozen or so AMIAS that have not sent their applications. I will not have statistics for you for this report but after recertification is complete, I will send a report directly to the District Representatives and/or District Alateen Coordinators.

You want to be an Alateen Sponsor? Check with your District Representative, District Alateen Coordinator, AAC (Area Alateen Coordinator) or AAPP (Area Alateen Process Person). You can also go to our Texas Website <u>http://texas-al-anon.org</u> to download the Al-Anon Member Involved in Alateen Service (AMIAS) Safety and Behavioral Requirements and Registration Forms.

Please read the instructions carefully to ensure you meet all of the Area Safety and Behavioral Requirements before submitting your application forms:

- 1. AMIAS Registration Form make sure you note the date of your training, where or who did the training.
- 2. Criminal Record Release Authorization
- 3. Al-Anon Member Involved in Alateen Service.

AMIAS Certification is done year-round. Anyone interested in serving as an AMIAS (Alateen Sponsor) must participate in an AMIAS Sponsor Training prior to submitting their application. Training is required for the first two consecutive years and every three years thereafter, during continuous service as an Alateen Sponsor. Joy in Alateen Service.

A downloadable version of the manual is available from the Members page of the Al-anon website <u>www.al-anon.org</u>. Once you have all the information together about your new meeting, then fill out and submit a Group Records Change Form (GR-1).

An editable version of the GR-1 is available on the Texas website. Go to *texas-al-anon.org*, click on the Members tab\* (\*password is <u>afg</u> or <u>anonymity</u>), scroll down to and click on Access Area 53 (Texas East), scroll down to GR Information, and click on Texas East Al-Anon Registration/Group Change Forms here. Type in the information, save the edited form as a .pdf file (be sure to remember what you name it and where you save it). Then email it to me as an attachment. I will enter the information in the database and turn it over to the World Service Office (WSO) for approval. WSO will notify you when your new group has been approved."

#### Public Outreach ~ Judy W. ~

Great activities continue in the districts by the District Public Outreach Coordinators (DPOCs)! Some reported activity highlights over the last quarter (March to May 2016) include: **From WSO:** Received and distributed the Public Service Announcements (PSAs) into the districts. Activities are underway for the districts to work together to ensure all TV stations are contacted. Radio PSAs were down in the past 6 months with only one PSA being played in Corpus Christi.

**District #5:** Continued to order Al-Anon Faces Alcoholism (AFA) magazines for distribution to GRs to use at businesses, hospital, churches, etc. Also, continuing to create "A Day in Al-Anon for Professionals". Contact has been made to reach the judges and law enforcement and working on proposal to share with professionals on why others may have an interest in Al-Anon. Budget will be approved by the district. Volunteers are needed to help support this large effort. Please contact Lynn B or district rep for more information to get involved.

**District #6 (North):** Participated in two health fair over the past month; Killeen & Fort Hood. Prescription pads are being used with professionals to give to their clients. A new meeting started in Cedar Crest Hospital (Belton) to attempt connection with families of the patients.

**District #7:** Planning to contact the GRs in the district to seek public outreach volunteer support. Continued effort to support the Woodlands Parents Group AFG (District 5). Attendance is up to 35+ and an effort to get the parents involved with public outreach is starting.

**District #8:** Spoke with the Franklin House North & Unity House several times. Setup an Al-Anon Information table at the Christus Health Fair. Distributed AFA magazines to doctors & hospital waiting rooms.

**District #9:** Voted to order AFA magazines at the last district meeting. Reported (as part of Tradition Six) to be cooperating with the local AA Central Service Office to share the magazine copies. Pamphlets (less cost) are also being considered for purchase & distribution. Began working other radio and TV stations that are not currently receiving the PSAs.

**District #12:** Two volunteers spoke at a Baptist Hospital System chaplain's breakfast meeting on Al-Anon and Alateen. As a result of that meeting, three chaplains want to distribute literature into 3 hospitals. More focal points are needed to help the chaplains. District 12 does not currently have a DPOC, but is seeking those that may have an interest to fill this position and/or assist in being the focal point contact for the other hospitals. For more information, contact the district rep (<u>dmw78247@aol.com</u>) if you have an interest to be of service.

At the last assembly, the DPOC team met to begin brainstorming ideas to carry the message into the area. Lots of good ideas were noted and a conference call to continue the discussions is scheduled for Saturday, June 6<sup>th</sup>, 10am.


and *AlAnon Faces Alcoholism* : Two very different purposes!

Many of us had to overcome multiple challenges before we were ready to give AlAnon Family Groups a try. We had to overcome denial that there was a problem with a loved one's drinking. Some of us didn't want to ask for help because it was embarrassing, and we didn't want anyone to know what was going on at home. Even if we were aware that AlAnon existed, perhaps the misconception that it's a religious group kept us away. Still others believed that no one could possibly understand what they were going through.

AlAnon Faces Alcoholism is designed to address those challenges. Members write about their own denial, or share how they overcame the fear of reaching out. Most of all, members share hope, understanding, and compassion with the potential newcomer.

In *The Forum*, members share how the various tools of the program including the Twelve Steps, Traditions, and Concepts of Service have helped them find—and keep recovery! Even the newcomer walking through the door for the first time, someone who has already overcome the challenges of reaching out for help, could benefit from reading the experience, strength, and hope that we share in *The Forum*. They may be confused by our Legacies and even some of the language we use, but AlAnon and Alateen members will be there to help. Imagine how daunting it could be for a potential member, someone who may have never even heard of AlAnon, to read about Concept Three or Tradition Five for example.

With that in mind, please encourage members and groups in your area to share *The Forum* with one another and share *AlAnon Faces Alcoholism* with their community!

#### <u>Austin AIS/LDC ~ Paula H.~</u>

The AAIC Board met on May 16, 6:30 P. M. at the Austin Al-Anon Information Center. Thirteen voting members were present.

The AAIC Chair, Joyce, is working on several items. She is in the process of updating the office manager guide, as well as filing a necessary report with the Secretary of State. Also, items have been donated to the AAIC for possible future computer use. A PC and iMac have been donated, as well as a printer, modem, and router. Joyce will continue to work to see if the donated items are compatible and will investigate Internet access. Also, another board member will investigate to see if the AAIC can get a less expensive phone, as the current bill is around \$90 a month.

The AAIC treasurer, Peggie, reported that the AAIC financials are up to date with the IRS and that it is currently operating in the black. However, Peggie suggested that another appeal letter might be sent to groups, and the Board will vote on sending another appeal letter at the August AAIC meeting. There was quite a bit of discussion regarding the AAIC budget, and it was determined that literature sales needed to be lowered to \$50,000. The budget was amended, and the amended budget was approved. Currently, the AAIC only has a checking account, but Peggie will open a savings account by June 1, 2016.

Two items of new business were discussed and votes were taken. The AAIC Board voted to bypass the By-Laws to extend the current secretary's term through December, 2016. Also, the Board voted to raise the .03 pamphlets to .04 for a bulk order of 100, and to raise the price of individual .03 pamphlets to .05.

Two discussions were tabled until the August AAIC Board meeting. The two discussion items concerned the volunteer committee and the literature committee. Concern was raised over the limited office hours that the AAIC is open, and the volunteer committee may look into extending office hours. This would entail soliciting more volunteer help for the AAIC. Also, literature sales were a concern, as sales have been dropping slightly. The literature issue will also be discussed at the August AAIC Board meeting.

Kitty, the AAIC office employee reported that daily calls and daily walk-in's had increased slightly over the past quarter. This increase may be a result of the District 6 public outreach project of putting Al-Anon posters on Capital Metro buses.

The next AAIC Board meeting is Tuesday, August 16, 2016, at 6:30 P. M. at Northland.

#### Area 53 Financial Checks N' Balances


All of our officers (Delegate, Alternate Delegate, Chair, Secretary and Treasurer) are signors on our checking account. Our duplicate checks require two signatures. The account has been set up so that both the Chair and the Treasurer have full online access to both the checking account and the CD account so that at any given time both individuals may check the status of the accounts and may view statements and copies of checks presented to the bank. A notification is also sent to the Chair in the event the balance on the checking account drops below a predetermined level. Additionally, an audit is conducted annually to insure that best practices are met.

All contribution checks received are copied and placed in a 3 -ring notebook, memorializing the contribution. All reimbursement requests and paid invoices are also placed in this notebook. Backups are made of the check register and the spreadsheet on a regular basis.

Finally, the P.O. Box has been set up to allow the Chair full access. The Chair has a key to the box and the Post Office has her contact information in the event of an emergency.

#### <u>TEA AC Report ~ Pat E. ~</u>

Dear Al-Anons and Alateens:

The Texas East Alateen Conference was held the last weekend in April at the Disciple Oaks Retreat in Gonzales, Texas. The attendance was down but those attending had a very good conference with the teens bonding and enjoying the weekend.

The original Host Group elected at the end of TEA AC 2015, Way Out Recovery Alateen, League City, notified TEA AC Chairperson, Pat E., that they would not be attending the conference this year and would not host the conference. Pat contacted the Bastrop Alateen Group, Ride to Sanity and they volunteered to be the host group. The conference theme HOPE was selected. In attendance from the entire area, Texas East, was 7 Alateens, 4 boys and 3 girls plus six sponsors, 5 female and 1 male. I talked with the camp director and advised that we could attend with this small number, but they would like to have a minimum of 20 attendees because of the food service.

We had attendance of two groups from District 6, one group from District 4 and one group from District 3. - At Conferences/Conventions/Assembly that Alateens ask for male members to be willing to serve

How to fund conference finances

- Donation cans at Coffee stand
- Sell desserts at family nights and city speaker events

What can we do to retain newcomers at our Alateen meetings

- Have a newcomer meeting
- Welcoming atmosphere, no "joking around"
- Avoid clique behavior, leave no one out
- Engage with the newcomer after the meeting
- Always have a warm and friendly atmosphere

Can you go back in time and remember what it was like and write down your thoughts? Would you consider writing a few words about any one of the bulleted items? For instance, perhaps you didn't want to go to Al-Anon because you thought it was religious, or you remember how hard it was to go to your first meeting and what you discovered when you finally got there.

You have something to say to a potential newcomer that will help them find their way to us and we want to hear it.

#### Writing Guidelines

- 1. Share an experience from the heart with the focus on yourself, not the alcoholic or others.
- 2. Relate a personal experience based on a program principle such as detachment, acceptance, a Step, Tradition, or Concept of Service, etc., and give an instance of how and where you used it.
- 3. Use the first person (I, me, we, us). True personal sharings do not give direction; they express your own experience, strength, and hope. Please avoid the use of the pronoun "you."
- 4. Avoid generalities, outside issues, treatment center language, and religious philosophy or doctrine. Al-Anon members in other Twelve Step programs, including Alcoholics Anonymous, are asked to write only of their experience in the Al-Anon program.
- 5. Kindly observe Al-Anon's Twelve Traditions when sharing.
