Hi Texas East Area 53,

I hope you have had a peaceful and serene holiday season (Thanksgiving, Christmas and New Year's)! I had fun seeing family and friends. This was not always the case, but due to the 36 principles of Al-Anon, I can visit and enjoy my family and friends in holiday settings that involve drinking. The Fall Assembly was a huge success and put us in a great frame of mind for the upcoming season. We had fun, fellowship, and did a lot of business and finished early in the afternoon. Here is a short recap.

Public Outreach. We passed the Public Outreach funding of \$3000.00 for posters and Public Outreach starter kits for the Districts to use.

Budget. We passed the budget for next year. However, we did notice that Group Contributions are down so we ask your Groups to consider supporting the Area. The Area thanks those groups who do send money. The money pays the expenses for the Area Delegate, Officers, and Area Coordinators. Currently our Group Contributions are down by about 40%.

Realignment of District Boundaries. We reorganized the Districts so that all groups in the Area are linked through a DR to the World Service Office. District 11 is no longer active so we moved all the Counties in District 11 to Districts 7, 8, and 9. We did not renumber the Districts. We also moved Caldwell County into District 6 as District 6 supports the Lockhart Prison Women's meeting, which is the only meeting in Caldwell County.

<u>Realignment between East and West Texas.</u> We also voted to add Kimble County to East Texas as the meeting in Junction attends District 13 functions, which is not reflected on the new map, as West Texas needs to approve this suggestion.

2017 Goals. As I reflect over the past year and make goals for the New Year, one thing that has been recurring in my meditation is **CARE**. Al-Anon teaches us to take care of ourselves. This means various things to people such as setting boundaries, personal hygiene, doctor's visits, *etc.* My goal for 2017 is to **CARE** for Al-Anon/Alateen. If we do not **CARE** for our Groups, Districts, or Area, Al-Anon may not be there for the newcomer who needs a new way of life and help with dealing with the effects of alcoholism. I **CARE** for my home group by showing up every week so that the doors of the meeting place are open for the newcomer. I **CARE** for my District by being part of the Fall Assembly Committee. I **CARE** for my Area by being willing to serve as the Area Chair. My service as Area Chair has pushed my spiritual growth to a new level. Left up to my own will, I would not have stood for Area Chair, however, I have learned in Al-Anon that I should be willing to stand for every position and let GOD/Higher Power decide whether my spiritual path should be enriched by serving in that service position, thus I stood for Area Chair. I am so grateful that I have been able to serve in this position. It has truly been a blessing in my life. I **CARE** for Alateen, by being an Alateen Sponsor, which is definitely outside my comfort zone, as I do not have children so the idea of being in a room of teenagers was frightening.



Delegate Report ~ Joyce Y.~

Joy of Service – Service has given me the opportunity to give back what has so freely been given to me. Some of the joys I have learned through Service are tolerance, responsibility, flexibility, vision, ability to listen and learn, strive to *do* as well as to *be*, participate, harmony and unity. What awesome gifts!!

Chosen Agenda Items (CAI) – The World Service Conference will discuss one CAI on Conference floor and 2 or 3 other topics in small group breakout sessions. The submissions should relate in some way to the 2017 WSC theme "Our Members: Our Hope for the Future". Topics that can be answered by using the Service Manual or are answerable by WSO department resources will not be eligible. Submissions date to me was extended until December 15 in order to meet required December 31 submit to WSO.

Meet the Board (MTB) – By "Getting in the car", over 100 members from Arkansas, Kansas, Missouri, Texas East, Texas West, Oklahoma, and Bermuda were in attendance for the October 22 MTB in Fayetteville, Arkansas. What an opportunity to experience the spiritual abundance of the program through sharing of volunteers in service, learning more about responsibilities of the Board and Executive Committee and their work based on spiritual principles in Al-Anon language as cited in Concepts and Traditions, work of the Board and Trustees to keep Al-Anon going forward and work to help recovery from the family disease. MTB now has a new name beginning in 2017 - "Road Trip! You and Your Board".

2018 International Convention – "Celebrating One Day At A Time" - July 5-8, 2018 in Baltimore, Maryland. The theme has multiple layered meaning: we are celebrating; we are celebrating one of our slogans, "One Day at a Time; and celebrating the 50th Anniversary of our daily reader "One Day at a Time in Al-Anon." As of December 1, 2016 the 2018 Convention is only 1 year, 7 months, and 3 days away. Check out this link <u>http://www.al-anoninternationalconvention.org/</u> for countdown and updates. Wouldn't it be fun to charter a bus and travel together! Who knows what might happen with this idea "One day at a time".

Spiritual Abundance – This is an expression of "giving back" out of gratitude. Through members practicing this principle in finances, contributions for 2016 were \$320,553 higher through September 2016 than the same period in 2015. With this kind of giving, the Board is very optimistic that we will meet and maybe even exceed our budgeted revenue numbers for 2016.

2017 World Service Conference – Our Members: Our Hope for the Future – April 24-28, 2017 Virginia Beach, Virginia – Wyndham Virginia Beach Resort Hotel.

2023 - International Convention Bid - I have submitted to WSO the Texas East bid for hosting the 2023 Convention in Houston. Thank you to Mattie T., District 4 DR, for all her contact and follow-up work with VisitHouston Convention Center as we worked together on the bid. Also thank you to Delores W., District 12 DR, for her footwork and efforts in San Antonio. What a team effort it has been. All bids will be reviewed for meeting the minimum requirements as well as feasibility of location and conforming bids will be submitted to the Board of Trustees for January 2017 meeting. Following the 2017 WSC, bid cities will make presentation to the Convention Site Committee who will screen info submitted and determine its top 3 choices. Based on inspection trip by a Site Selection Committee to the top 3 cities, a choice will be recommended to the Board in October 2017 or January 2018. The Board of Trustees has overall responsibilities, but there will be numerous opportunities to serve on the Host Committee for the successful area.

World Service Office Changes – Welcome to Niketa Bailey (non-member) as the new Director of Finance (changed from Director of Business Services) for Al-Anon Family Groups, Inc. In welcoming Niketa, we will be saying goodbye to David Zach, Director of Business Services who will retire in January.

There will be an article in January to help members understand the difference in writing a sharing for The Forum and writing for a daily reader. Many of the sharings we have received for the new daily reader have been more like *the Forum* sharings. Staff will e-mail a draft of this article to the Literature Coordinators, with the understanding that they use it as a resource, but not make and distribute copies.

Please keep in mind when considering new writing workshops that the WSO always needs sharings on the Traditions, Concepts, and Steps Four through Twelve. In addition, the Literature Committee would like the new daily reader to be the first one to include a sharing on each Step, Tradition, and Concept of Service.

Encourage members to purchase printed literature over electronic literature. The Associate Director—Literature, Tom

Coffey, shared that we encourage the purchase of all CAL electronic and print—because all sales support the WSO and services for members. Many members do not know that eliterature exists. The WSO now lists the specific vendors that e -literature is available through to make it easier for people to find. One coordinator received a request from a local member for more large-print literature. An advantage of ebooks is that you can make the print as large as you want.

The Policy Committee is finalizing its work on incorporating spiritual principles into the text portion of the 'Financial Matters' section of the "Policy Digest," pages 95-99, and the text of 'Conventions and Other Events' formerly title 'Conventions,' pages 85 and 86, of the 2014 -2017 Al-Anon/ Alateen Service Manual (P-24/27). The goal of the Committee is to bring the revised text for both sections to the 2017 World Service Conference (WSC).

<u>Group Records ~ Candy N. ~</u>

I was recently asked for feedback by our Area Delegate concerning "Open" and "Closed" meetings. Based on the Change Forms I receive, I realized that many individuals and

groups in our area do not fully understand the terms. Page 36 in "Groups At Work 2014-2017" P24/27 describes both. "Open" Al-Anon meetings allow attendance by people who are not families and friends of alcoholics such as professionals or students who work with alcoholics and their families. "Closed" Al-Anon meetings are limited to those who are affected by someone else's drinking. By default, Al-Anon meetings are "Closed" unless declared "Open" and all Alateen meetings are "Closed". "Open" and "Closed" meetings should not to be confused with "Active" and "Inactive" meetings.

An editable version of the GR-1 is available on the Texas website. Go to *texas-al-anon.org*, click on the Members tab* (*password is <u>anonymity</u>), scroll down to **Texas Areas** and click on Access Area 53 (Texas East), scroll down to Group Records Change Forms, and select either the English or Spanish Group Records Change Form GR1. Type in all available information, mark what is to be changed, save the edited form as a .pdf file (be sure to remember what you name it and where you save it). Then e-mail it to <u>candyn07@icloud.com</u> as an attachment The form can also be sent by regular mail. Gratefully in service.

The starter kits and posters that were requested by the District Public Outreach Coordinators (DPOCs) were totaled, budgeted as a motion not to exceed \$3000, and approved at the Fall Assembly by the group representatives. The materials have been ordered.

A motion was made and approved to accept the Meeting minutes from the AWSC Meeting in Houston on August 6, 2016 as published in the *Beacon*.

Treasurer: Tricia L. gave update on the Area's bank balances. Went over proposed 2017 budget. Will present the budget to Assembly with same numbers as 2016 budge. Reported that the Area is approximately \$9,000 under the projected income for 2016 with two months left in the year and asked members take this information back to their groups. Requested that all officers and coordinators turn in all unpaid expense reports to her by December 1, 2016.

Area Delegate Report: Joyce Y. reported that the 2017 World Service Conference will be held April 24-28, 2017. A Board of Trustees meeting will be held on April 29, 2017. Discussed that the time is drawing near for the WSC to chose Chosen Agenda Items for the 2017 WSC. Asked for input on topics to present and that they be sent to her by December 1, 2016. 

East Texas Al-Anon/Alateen Assembly November 5, 2016 Corpus Christi, Texas

Opening: Kay C., Chairman opened the meeting at 9:14 am. The 12 Traditions and the Concepts were read. Thanked everyone for coming and honoring their commitment to themselves and their groups. Roll call procedure was explained. Officers were introduced.

Delegate's Report: Joyce Y., Area 53 delegate reported she has visited 4 of the Area's Districts and is scheduled to visit 4 more in 2017. Thanked everyone for Love Gifts and messages sent to her at the 2016 World Service Conference (WSC). Texas has a good reputation for their Love Gifts. The next WSC will be April 24-28, 2017 at the Wyndam Hotel in Virginia Beach, Virginia. The theme will be "Our Members: Our Hope for the Future". Joyce explained about Delegate Equalized Expenses and how this spreads the costs to attend the WSC so that all Delegates pay the same amount. She asked for input from the Assembly on possible Chosen Agenda Items for the 2017 WSC. Please send ideas to her by December 15, 2016. Don't submit topics that are already covered by the Service Manual. Three topics will be chosen for the WSC, one for discussion on the floor of the conference and two will be discussed in breakout workshops. Joyce also asked for input from the Area Assembly regarding the topic of the Just for Today bookmark and the use of the Prayer of St. Francis. She stressed that the decision has not been made to remove the prayer but that the topic will be discussed at the next WSC. Joyce encouraged all to read Conference Summaries which are available on the WSO website. All past summaries are available. Joyce also discussed the topic of the term "Closed Meeting". Should this name be changed to something else as it can sometimes cause confusion among those that don't understand the term as it is used. She also conveyed that the WSO has had an increase in donations that has closed the deficit.

Complete Delegate report will be in the Beacon.

Chosen Agenda Items:

1.) Funding of Area Public Outreach Projects

Kay C. presented that Judy W. has been working with Districts to come up with public outreach projects. Two projects were proposed and presented. First project is a Starter Kit project. Area to provide public outreach kits to Districts for distribution to schools, health fairs, professionals, etc. Area would order materials for kits in bulk for more economy and distribute to Districts. Project two is for the printing of public outreach Posters for distribution to schools, libraries, etc. The Area will order posters and distribute to the Districts. The Public Outreach committee is requesting that the Area commit \$3,000 to fund these two projects from the Area's regular checking account. Discussion followed.

2.) Proposed Budget for Texas East Area 53 for 2017 Fiscal Year

Tricia L presented the proposed 2017 Budget. All budget items will remain the same dollar amounts as the 2016 budget. Discussion of the budget and the effect of the proposed \$3,000 commitment for the proposed public outreach projects followed.

3.) 2023 International Al-Anon Convention with AA Participation

Kay C. presented the topic of Texas East Area 53 putting in a bid to the WSO to host the 2023 International Al-Anon Convention. Presentations were then made for two possible host cities for the Convention. Mattie T., District 4 Representative gave a presentation on the merits of having the Area present Houston as the host city. Dolores W., District 12 Representative then gave a presentation on the merits of having San Antonio presented by the Area as the host city. Both presentations were able to host the convention either June 30 – July 2 or July 7 – July 9. Discussion followed the presentations.

4.) Changing Boundary between East and West Texas.

Kay informed the Area that she had received information that during our past assembly discussion and voting on redrawing the boundary between East and West Texas, Kimble County was overlooked. This County is in West Texas and has one group in Junction that has been participating and wishes to continue to participate in District 13 of East Texas.

5.) Changing Boundary between District 11 and Districts 9, 8 and 7. Kay opened discussion. Due to the inactivity of a District level of service in District 11, Kay proposed moving the counties in this district to neighboring districts as follows: Freestone, Anderson, Cherokee and Nacogdoches Counties to District 9. Angelina County to District 8. Leon, Houston and Limestone Counties to District 7. Discussion followed.

6.) Changing Boundary between District 3 and District 6.

Kay discussed moving Caldwell County from District 3 to District 6. There is only one meeting in the County in a prison that is hosted by a group from District 6. Discussion followed.

7.) Archivist Position. Kay informed the Assembly that Becky F. has stepped down as Area Archivist. The position is available for 1 year term.

Meeting adjourned for lunch.

Meeting resumed at 12:40 pm with Roll Call. 97 voting Group Representatives were present broken down by District as follows. D1 (5); D2 (11); D3 (5); D4 (7); D5 (15); D6 (19); D7 (5); D8 (10); D9 (4); D10 (1); D11 (0); D12 (12); D13 (3). By consensus, the voting method will be by simple majority. (49 needed for simple majority). It was also agreed that voting would be by standing and counting off with the exception that the vote to choose between San Antonio and Houston for the International host city be done by ballot.

Secretary: Motion was made, seconded and approved to waive reading and accept the minutes from the business meeting held May 14, 2016 Assembly held in Kerrville as published in the Beacon. (Vol. 48, Issue 4).

Treasurer: Tricia L. passed the gratitude basket (\$865.05 was contributed). Contributions will remain for Area 53 use.

Area has \$32,007.32 in bank account and \$20,069.98 in the ample reserve fund. There are balances of \$6,460.30 in the P.O.S.S.E. account and \$6,733.05 in the TEA AC account. The Area's Ample Reserve Fund (CD) matured June 30, 2016 and it was closed and a new CD created at 1.05% interest rate. Upcoming expenses include: The Delegate's equalized expenses for the upcoming WSC. The Area pays the full amount of the equalized expense rounded up to the nearest

\$100.00.

Alternate Delegate/Literature Coordinator's Report: Margaret F. gave Forum and Literature Report. Give Forum subscriptions as gifts. There are free subscriptions to AFG Announcements available online. Just send in you email address to the WSO at the members website. *Lois and the Pioneers* is available for rental from the WSO. Alateen chat meetings are available online via a PC or Laptop. Cannot be accessed by phones. Sharings needed for Forum Book and new Daily Reader. The Area voted to present Houston by a vote of 63 for Houston, 30 for San Antonio and 4 abstentions. A motion was later made that the Area submit a bid to host the Convention in Houston. This motion passed. (See Motion 7 below)

4.) Change in Boundaries between Texas East Area 53 and Texas West Area 54 Topic of changing the East Texas/West Texas boundary by moving Kimble County from West to East was opened for discussion. A motion was made to move Kimble County from Texas West to Texas East. This motion passed. (See Motion 3 below)

5.) Changing Boundary between District 11 and Districts 9, 8 and 7. The topic of moving the counties currently belonging to District 11 to neighboring districts was opened for discussion. A motion was made that Freestone, Anderson, Cherokee and Nacogdoches Counties be associated with District 9. This motion passed. (See Motion 4 below)

A motion then followed that Angelina County be associated with District 8. This motion passed. (See Motion 5 below)

A final motion on this topic was then made that Leon, Houston and Limestone Counties be associated with District 7. This motion passed. (See Motion 6 below)
