A Message from the Chair ~ Kay C. ~

Dear Texas East Area 53,

Well, I thought my last report was my last, but Lynn asked us to write a "wrap-up" report for the first quarter edition of the 2018 *Beacon* so here we go. I have had a wonderful spiritual journey being your Area Chair, and I look forward to being Delegate to the World Service Conference. The Fall Assembly was a tremendous success with 188 Al-Anons, 10 Alateens and 5 AAs in attendance. We also had more voting GRs in attendance than the last Assemblies (120 vs 97). I hope we can keep this trend going. Thank you District 6 for hosting this event. I know you had some obstacles, but in the spirit of love, everyone (especially Anna) stepped-up and nothing was missed.

On reflection of the discussion around what a "majority" is, I think it was a great experience for us all and firmed up my belief that Knowledge Based Decision Making (KBDM) is the only way to conduct business. Since the election instructions were not clear to everyone, we had a medium long discussion (about 1 hour) on what a "majority" meant and then motion came out of that discussion as to how a majority of votes pertained to the election of the Chair, Secretary, Treasurer, and Coordinators. Ironically, we did not need a definition of majority for the rest of the election as only one person stood for each office. In retrospect, maybe we should have dealt with that issue when it was actually needed. Oh well, we have three years to refine our balloting procedures. Luckily, the 2018 WSC Conference Summary has a lot of guidance as voting revisions were approved for the Al-Anon Alateen Service Manual.

We have several items for the new panel to continue to discuss and hopefully bring to the Assembly with a clear plan of action. They are 1) Assembly Liaison roles and responsibilities, and 2) realignment of Districts 4, 5, and 7. The AWSC has been asked to review Assemblies (e.g., length, content, etc.). We have used the same format since 1997 so some updates/changes are probably needed. Let Lynn or I know if you have any thoughts or suggestions. I am excited about the new panel and know they will bring fresh ideas to all of these subjects. If you have any questions, please contact me at my new email kacetxdel58@gmail.com.

Realignment of Districts 4, 5, and 7. Recently, there has been some discussion as to how the realignment should have been approached, for example, should Districts 4, 5, and 7 decide on what is best, or the Area. Actually, it should be a combination of both as the division of the districts effects the unity of the Districts and the Area as a whole (Tradition 1). The September issue of the *Beacon* had an article on how the unity of the Area (including the districts) is affected by having a district with over 130 groups. The Service Manual provides guidance on how a district is formed.

The **district** is a geographical segment containing a number of groups, located relatively close to one another. Group Representative attend district meeting to discuss business matters, and share their group experiences with each other. (*Al-Anon Alateen Service Manual*, page 71) **Districts** Convenient segments into which an Area is divided by the Area World Service Committee, with the approval of the Assembly. (*Al-Anon Alateen Service Manual*, page 132).

An advantage of dividing into smaller **districts** is that they can be covered more conveniently by the DRs. (*Al-Anon Alateen Service Manual*, page 150)

The AWSC established a Task Force to propose convenient segments that are relatively close to one another in Districts 4, 5 and 7 with input from the effected districts. The efforts have included:

Numerous meetings and discussions within the Task Force and gathering input from members;

A presentation and Q&A at the 2017 Spring Assembly;

Discussion and Q&A at several District 4, 5, and 7 district Meetings (The Task Force held a presentation and answered question at 3 separate District 5 meetings);

A Q&A meeting was held in the Memorial Area of Houston;

A letter was mailed to all the groups in the District 5 to ask them to vote by email to Redistricting.Reponse@gmail.com;

An email was sent to all the groups in the District 5 asking them to vote;

The deadline for responding was extended to allow more time for recovery from Hurricane Harvey and to encourage participation;

A volunteer phone tree was created to call all the groups in District 5 that had not yet voted to ask them to vote by email or at the district meetings.

As of December 1, 2017, only 30% of the groups in District 5 had expressed an opinion. Said another way 70% of the effected groups in District 5 have not expressed their opinion. Of the 30% that voted, 82% of the votes were "Yes" to realign. A breakdown of the votes is shown below.

Some have expressed an opinion that more discussion needs to be had over where the new districts should be and how many.

2018 World Service Conference – Al-Anon There is No Standing Still will be held in West Harrison, New York, April 16-20, 2018, instead of Virginia Beach this time. The New York site will allow the opportunity for the full Conference to visit Stepping Stones during Conference Week.

"Celebrating One Day at a Time" - 2018 International Convention - July 6-8, 2017. Online registration can be easily completed by going to www.al-anon.org and clicking on the International Convention link in the top righthand corner of the website. Our Convention block of hotel and lodging options will be available once you complete your registration. Be sure to note your registration number as it is required to complete your hotel reservations. Dates for the 2018 International are Friday, July 6th-8th. Registration fees are \$130 through December 31, 2017; \$165 January 1-May 31, 2018; \$195 June 1, 2018 through the event. Can you picture yourself in Baltimore in 2018?

Day of Connecting: In addition to the International Convention, a Day of Connecting has been planned by the Board. The Day of Connecting will be held on Thursday, July 5th. Registration is a separate fee of \$40 and will increase to \$45 after May 31, 2018. It will be a day of learning, sharing and deepening your understanding and commitment to our third legacy: Service.

50th Anniversary One Day at a Time in Al-Anon (ODAT) commemorative edition, complete with gold lettering on the cover and gold ribbon book mark has been approved by the Board. This special edition of the ODAT will be available at the 2018 International Convention and for the remainder of 2018 until supplies are gone. A limited number of books will be printed and for a purchase price of \$15. A commemorative book plate will be included only for those purchased at the convention.

2023 Al-Anon International Convention – Congratulations to Albuquerque, New Mexico as the chosen site for the 2023 Al-Anon International Convention.

Finance Update: As of end of third quarter 2017, literature sales are ahead of budget. Unfortunately, contributions are below projections based on our 2017. What does this mean in numbers? If broken down visually and into smaller numbers to understand what \$600,000 could look like and how attainable that number really is, we would easily meet our budgeted 2017 contributions goal if 60% or 9,000 of all our registered groups contributed \$60 and 5,000 members contributed \$15 each and 55 Areas contributed \$500. The Board and staff thank you for continuing to think abundantly.

Service, the third legacy, has given me the biggest boast to my recovery. I look forward to continuing my service journey as a Past Delegate and a longtimer. Lois W. in her letter to the Longtimers in Al-Anon in Many Voices, One Journey (B31), Pages 146-147, provides insight on how to transition from long-timers to those younger in service. "From a place on the sidelines, oldtimers can give the group purpose and continuity, but not management—unless asked to fill a special function. We are always willing to help where we can, but the active leadership of the group should be in newer hands."

In October I participated in a WSO conference call for Area Group Record Coordinators. It was the last of several such conference calls. Most of those attending were from the northwest United States and Canada. WSO was concerned about "broken links" when it came to accurate and up to date meeting information. WSO wants to encourage the Areas to use the

WSO database as it is so difficult to sync multiple databases. They were requesting input from us to help revamp their database so the meeting lists can be user friendly and more helpful for the newcomer. For example: discussion meeting, step meeting, literature meeting, Alateen or AA meets at the same time, stag meeting, women only, better meeting location instructions.... So whatever your desires are, please let me know. I will notify WSO through AFG Connects.

WSO recognizes it is imperative the newcomer can find a meeting. They have discovered that many of the "Reported Not Meeting" notifications are due to insufficient meeting location directions. It's not that the meeting is no longer active, it is that the newcomer can't find it! In that vein, they have already expanded the "Location" field and now allow upper case letters.

One of the things WSO already has in place is the "WSO Locator" with Google Maps. Any website can link to WSO's Meeting Locator by contacting Scot Powers at WSO (scot@alanon.org). This feature allows anyone to enter a zip code and find the meetings nearby. This certainly helps with locating meetings in the same place with different names.

District 6 ~ Judy W. ~

Many groups elected new Group Representatives (GRs) since our last report. We have between 80 to 90 registered groups in District #6 and are the second largest district is East Texas Area (ETA); District #5 is the largest district with a very densely populated Harris county area of over 130 groups. At our district and assembly meetings we average ~22 voting GRs; under 30%. Anna A (our new Alternate District Rep & recent Fall Assembly Chair) hope to visit more groups to encourage more participation in district and area business activities and to take information back to their group as a critical link of service.

District 6 Meeting Highlights (from October 26th):

• Attendance included: a total 45 Al-Anon members

- (including one Alateen and 26 voting GRs)
- Discussed election procedures using the service manual
- Conducted elections which resulted in naming a full set of officers and coordinators (first time in three years)
- Provided updates from outgoing officers and coordinators
- Received updates on old business topics; a) Distributing Alateen School Posters, b) Increasing Alateen Membership
- Dissolved the Unallocated Funds for Public Outreach Thought Force until next year's 2018 budget can be set to engage participants
- Formed a new Thought Force to establish a 2018 district budget
- Asked that groups consider hosting 2018 meetings in January, April, July & October. (A list of roles/responsibilities for the district hosting groups was drafted and we hope to queue up other hosting locations soon.)

Assembly Fall (Business) Highlights (from November 5th):

Attendance included: a total 203 registrations which included 5 AA, 10 Alateens, and 188 Al-Anon members. Of the 188 Al-Anon attendees, 121 were voting ETA GRs which included 28 voting District 6 GRs.

Financially, the event was a success with a surplus of \$712.41 after returning the area's \$3500 seed money and the District 6's \$2500. Received a detailed report from the Treasurer Chair which contained other useful notations.

Several host committee chairs have submitted their reports and the final report (containing all chair report highlights) is being composed to share with the area and other districts.

East Texas Al-Anon/Alateen Assembly November 4, 2017 Austin, Texas

Opening: Kay C., Chairman opened the meeting at 9:19 am.

Delegate's Report: Joyce Y., went over Chairman of the Board letter. Reminded those in attendance that the Al-Anon International is coming up in Baltimore, Maryland July 6-8, 2018. There will be a "Day of Connecting" on July 5, 2018 planned by the Board of Directors. There will be workshops and presentations. The 2018 World Service Conference will be April 16-20, 2018 in West Harrison, New York. The theme is "Al-Anon-There is No Standing Still". WSO Website has been updated. The Board approved the sale of a 50th Anniversary Edition of the daily reader One Day at a Time in Al-Anon it will be available until the end of 2018 or they run out. This year contributions to the WSO are \$600,000 below projected amount with 3 months left in the year. The Nominating committee is looking for a member at large to serve on the Executive Committee for Real Property Management. Resumes due by November 30, 2017. The 2023 International Al-Anon Conference will be in Albuquerque, New Mexico.

Complete Delegate report will be in the Beacon.

WSO Vision: Vali F, new WSO Executive Director introduced herself to the Area giving a brief summary of her qualifications and personal background. She then explained the duties of her position, oversight responsibility for all functions of the WSO and to make sure they are meeting the needs of the fellowship. Discussed the shift to technology and changing demographic of the membership. Her primary responsibility is to empower the team at the WSO and to help work towards the Board Mission Statement: "Anticipate the future and Al-Anon's place in it and ensure that the necessary resources are available.

Conversation Items:

- 1.) **Budget:** Tricia L. presented the 2018 Area 53 budget and explained how budgeted amounts were determined. Answered questions from the floor.
- 2.) Delegate Expenses to the Al-Anon International: Joyce Y. talked about a line item in the 2018 budget to pay for Area Delegate expenses to attend the International. Explained that if this addition to the budget is approved by the Area it needs to be done with a motion so that there will be a record of the transaction. Discussion followed.
- **3.) Alateen Liaison:** Brendan G. has been elected by the Alateens in attendance as the new Area Alateen Liaison.

4.) Coordinator Reports:

Coordinator reports were given by: Judy W. (Public Outreach), Candy N. (Group Records), Ann R. (Archivist), Anita C. (Spanish), Lisa W. (Website), Bennie P. (Alateen & Alateen Process Person), Lynn S. (Beacon Editor), Margaret F. (Forum). The reports are on file and will be in the *Beacon*.

5.) Update on Task Forces: Kay C. gave an update on the District 4, 5 & 7 Realignment Task Force is working on this reaching out to groups in the districts for feedback. This task force will continue on into the next panel. A new deadline of November 30, 2017 was established for groups in the District 5 to respond to the topic. So far 42 out of 130 groups have

responded. Kay also gave an update on the Assembly Liaison Task Force. The task force is working on roles and responsibilities and will make a presentation at the next AWSC meeting.

Meeting adjourned for lunch at 11:30 am

Meeting resumed at 1:00 pm with Roll Call beginning at 1:15 pm. 121 voting Group Representatives were present broken down by District as follows. D1 (6); D2 (8); D3 (3); D4 (10); D5 (26); D6 (28); D7 (9); D8 (4); D9 (6); D10 (1); D12 (16) D13 (4). Number needed for majority is 61, number needed for 2/3 majority is 81. Kay C. went over voting procedure for elections. For Delegate and Alternate Delegate must be elected by 2/3's vote. All other positions by majority.

Secretary's Report: Motion was made, seconded and approved to waive reading and accept the minutes from the business meeting held May 20, 2017 Assembly held in Sugar Land as published in the *Beacon*. (Vol. 49, Issue 4).

Treasurer: Tricia L. passed the gratitude basket (\$1,065.18 was contributed). Contributions are to remain in the Area.

Area has \$40,772.12 in checking account and \$20,270.92 in the ample reserve fund. The balance in the POSSE account is \$6,460.30 and in the TEA AC account is \$5,744.34. Area World Service Committee Meeting November 3, 2017 Austin, Texas

Chairman: Kay C. opened the meeting at 10:06 pm.

Secretary: David S. called the roll. 23 voting members of the AWSC present. The following AWSC Officers and Coordinators were not in attendance: Alateen Coordinator. The following Districts had no representative in attendance: District 5. The following AIS/LDCs had no Liaison in attendance: Houston and Houston Hispanic.

A Motion was made and passed by consensus to accept the Minutes from the August 12, 2017 AWSC meeting in Victoria as printed in the *Beacon* (Vol. 49, Issue 4).

Treasurer: Tricia L. presented the current financial condition and proposed 2018 budget for the Area. Currently \$40,772.12 in Checking Account, \$20,270.97 in CD (Ample Reserve). POSSE balance is \$6,460.30 and TEA AC balance is \$5,744.34. Tricia reported that income for 2017 exceeded budget projection due to income from Assemblies. Actual donations to the Area were below projected amount. The CD rate of the ample reserve account was up this year and was set up as an 18 month CD in order to get better rate and to give new Treasurer time to learn position before CD needs renewal.

Area Delegate Report: Joyce Y. reported that the 2023 Al-Anon International will be in Albuquerque, New Mexico. Contributions to the WSO are down this year with a current shortfall of \$600,000. It is hoped that funds will increase in the final 3 months of 2017. There is an opening to serve on the Executive Committee for Real Property Management. Resume must be received by November 15, 2017. The 2018 Al-Anon International is coming up July 6-8, 2018 in Baltimore, Maryland. Encouraged everyone to go and to go a day early to attend the "Day of Connecting" being hosted by WSO Board Members and Staff.

Alt Delegate/Literature Report: Margaret F. will give her report tomorrow at business meeting. Presented the Secretary with an old folder of meeting minutes to be used to compare with Area records.

Unfinished Business:

- 1. Update on Realignment of Districts 4,5 and 7: Mattie T. reported that the realignment committee has met several times reaching out to districts for input. Have been reaching out to all groups in District 5 via US Mail, email and by phone. The deadline that had been set to receive input on the realignment from the groups was extended to November 30, 2017. To date have received feedback from 36 groups in District 5, 30 for and 6 against realignment. District 4 and District 7 are very open and positive towards the realignment.
- 2. Assembly Liaison Update: Joyce Y. reported that the Assembly Liaison Committee is in the process of reviewing input from the last AWSC meeting.

New Business:



Minority Opinion Letter: Nancy M. discussed a letter she had sent out to all AWSC members regarding the Area Assembly Guidelines Task Force she served on and actions which were taken following a vote at the February 4, 2017 AWSC meeting. After discussion, it was agreed by the AWSC members present that there had been confusion regarding what had been discussed and voted on at the 2/4/17 meeting and that the AWSC needs to regroup and work on clarifying the topic so that it can then be presented to the Area Group Representatives in a concise way so that they can make in informed decision on how the Area wants to go forward in the future with the format of Area Assemblies.
- 2. Approval of Area 53 Business Meeting Agenda: Kay C. presented the proposed agenda to the AWSC for discussion. She discussed voting procedures for tomorrow's elections and will have a power point presentation at the morning GR meeting as well as during business meeting to explain voting procedures. She suggested having a separate discussion item to go over Delegate expenses to the Al-Anon International in Baltimore.
