2018-2021 Al-Anon/Alateen Service Manual (P-24-27) The new service manual is available online at <a href="https://al-anon.org/for-members/members-resources/manuals-and-guidelines/">https://al-anon.org/for-members/members-resources/manuals-and-guidelines/</a>. You can download a PDF of the manual from this web page. The paper copy is available for \$5.00. Groups will not be getting a complimentary copy so your group and/or GR will need to purchase a new manual. However, groups will be getting a complimentary copy of the GROUPS AT WORK (P-24) section of the manual.

2018 World Service Conference – *Al-Anon There is No Standing Still!* The WSC April 16-20 will be held the year in West Harrison, New York, April 16-20, 2018, instead of Virginia Beach. The New York site will allow the opportunity for the full Conference to visit Stepping Stones during Conference Week. WAHOO! Day of Connecting: In addition to the International Convention, a *Day of Connecting* has been planned by the Board of Trustees. The *Day of Connecting* will be held on **Thursday, July 5th**. **Al-Anon Membership survey.** The 2018 Al-Anon Membership survey is now closed and the results are being compiled. Thank you to all that participated. This is the only means Al-Anon has to help discern who comes to Al-Anon, how they got here and why members stay.

#### **Financial**

WSO received \$1,972,931 in contributions in 2017 and literature sales of \$3,523,843 (based on unaudited financial statements). The 2017 contributions reflect our second highest year of contributions. Literature sales reflect an increase of \$186,192 from 2016. 57.5% of the active groups in Area 53 contributed \$41,590.41. This is up about \$5500 from last year. I think this is great. Does your group contribute to the Service Arms in your District (District, Information Center, Area, and WSO? More importantly your contributions and literature sales reflect the resources necessary for the WSO Staff to develop and provide the following new programs and services in 2017 and beyond:

- Completion of the newly designed al-anon.org website
- Completion of the newly designed Members link on the al -anon.org website
- $\mbox{\ }$  Ability to hire and retain Staff versus the expense of outside consulting
- Completion of the new meeting search
- Ability to not only look to the future but the continued commitment to our primary purpose of reaching families and friends of alcoholics.

The average contribution for Area 53 Group to WSO is about \$164 and the cost to WSO to support each group is about \$280.00. I understand that every group does not have the means to send contributions to WSO, but every \$1.00 sent helps.

Happy Spring to Texas East Area 53 AFGs, thank you for electing me to represent you all as your Alt. Delegate and Area Literature Coordinator. Here's the latest update of literature news.

- Understanding & Hope for Parents & Grandparents (P-94): This new pamphlet is being translated into French and Spanish as I write this. We hope to introduce it at April's World Service Conference and have it available to the fellowship in May. Priority order forms will be posted to the Literature Distribution Centers on AFG Connects prior to that.
- Intimacy in Alcoholic Relationships—A collection of Al-Anon personal stories: This highly anticipated new book is expected to be introduced in Baltimore at the 2018 Al-Anon International Convention in July. Priority order forms will be posted to the Literature Distribution Centers on AFG Connects prior to that.
- 2019 CAL Catalog (S-15) and CAL Order Form (S-16): In order to include our newest Literature in them, these free service tools will be available beginning this summer.
- NEW DAILY READER (working title): Please continue to encourage members to submit sharings for this project, especially on the Steps, Traditions and Concepts of Service.
- "CAL Corner": Each month, the "CAL Corner" feature in The Forum includes members' sharings on how a particular piece of our literature has enhanced their recovery. The February articles feature Discovering Choices (B-30). March's are about Lois Remembers (B-7), in celebration of her birthday. April's articles cover Paths to Recovery (B-24) and the Paths to Recovery Workbook (P-93).

The following 20 quotations (in English, Spanish, and French) from Conference Approved Literature can be used by Al-Anon service arms in 2019 calendars without completing the usually required reprint permission request form. For those service arms that wish their calendars to focus on the "Step of the month," the first 12 quotations are about the Twelve Steps. Eight other quotations on a variety of topics are also provided. You may use as few or as many of these quotations in your calendar as you wish. As a service arm, you may also quote any or all of the Steps, Traditions, and Concepts of Service, provided you do not alter them in any way. The only stipulation is that you include the attribution to the quotation immediately following it, and that somewhere in the body of the calendar, you include the following credit line:

Step One puts the focus back on me, not on the alcoholic. My attempts to control others make my life crazy, but by letting go, I become free. Those around me find freedom to make their own mistakes and face their own consequences.

Reaching for Personal Freedom—Living the Legacies (P-92), page 11

In Step Two we realized we didn't have all the answers and that "a Power greater than ourselves" could help us. Many of us call this Higher Power "God." Some of us feel this is the group. It doesn't matter, as long as we really believe in something outside of ourselves that can help us.

Alateen—Hope for Children of Alcoholics (B-3), page 14

If someone can't be a loving witness to my sadness, I can learn to accept it without resentment. Step Three helps me do this. When I think something isn't right in my world, I remind myself that I turned my will and my life over to the care of a loving Higher Power this morning. Even if my expectations are not met, I am still safe.

Opening Our Hearts, Transforming Our Losses (B-29), pages 45

Step Four is an exercise in perception, a way to distinguish between what works in our lives and what is no longer useful or necessary. Being aware of what we did yesterday can help us understand and accept who we are today, so tomorrow we can become the people we want to be.

Blueprint for Progress: Al-Anon's Fourth Step Inventory (P-91), page 9

For the first time that I could remember, I felt I was *truly* a human being. It took my Fifth Step to really show me I was not from another planet, but someone who belonged on earth, at one with humanity. If I had not risked admitting my characteristics to another human being, I would not have healed an important part of my life—my relationship to other people. *From Survival to Recovery: Growing Up in an Alcoholic Home* (B-21), page 193

The Sixth Step is an inspiring challenge to surrender ourselves to the guidance of our Higher Power. I will read this serenely beautiful statement of submission to God's will as often as I have need of it . . . My goal will be to make myself "entirely ready"—to let go of the negative habits of thought that have been reflected in the happenings of my life.

One of my greatest fears about Step Seven was that there would not be anything left of me when I gave up my shortcomings. When I let go, however, God showed me the behaviors, motivations, and attitudes that I wanted to nurture and grow within me.

One Day at a Time in Al-Anon (B-6), page 172

Whether we have made carefully considered choices that feel absolutely right for us or have acted impulsively out of fear or anger, our actions have consequences. Sometimes other people get hurt. By taking Step Eight, we acknowledge this fact and become willing to make amends. With this Step we sort out our part, taking responsibility for our actions but also releasing ourselves—and possibly others—from the burden of falsely-held responsibilities.

... In All Our Affairs: Making Crises Work for You (B-15), page 186

I recently finished my Ninth Step and experienced a wonderful sense of freedom. I was able to see those things I kept doing over and over that for all my good intentions, did not give me the results I wanted. After working through the Steps, I noticed with wry humor that the people closest to me have certainly begun acting a lot better.

Discovering Choices (B-30), page 190

Today I accept myself as imperfect and allow myself to make mistakes. When I do, I use the Tenth Step to help me forgive and amend my own behavior. I find that the more I learn in Al-Anon, the less frequently I act against my own best interests, and the easier it is to forgive myself when I do. Hope for Today (B-27), page 49

In Step Eleven I seek to improve my conscious contact with God through prayer and meditation. How I do this is completely up to me. . . . Whatever path I choose, I know I must keep trying as often as I can to follow the course offered to me by my Higher Power. Only in this way can I be confident of my actions; only in this way can I find the courage to change. Courage to Change (B-16), page 165

Step Twelve invites us to stay on our path to recovery. We

must continue our maintenance work so we won't slip back into old patterns. To continue, we need to share all that we have been given with other families and friends of alcoholics. To keep it, we have to give it away.

Paths to Recovery—Al-Anon's Steps, Traditions, and Concepts (B-24), page 121

To be happy today, we have to let go of our shadow worlds. For most of us in Al-Anon, this is made possible through considerable spiritual effort, one which we need to make whether or not the alcoholic finds continuing sobriety.

Living with Sobriety (P-49), page 43

I am so quick to perceive what I suffer from others, but so slow to notice what others suffer from me. *Blueprint for Progress* (P-5), page 34

Detachment did not mean disinterest. For me, it meant respect for another. With detachment, I kept my hands off my family's situation, and I did not interfere while my son struggled toward his own recovery.

To Parents of Alcoholics (P-16), page 14

Al-Anon for me is a program for living—a design for living. I've found a certain sense of reality—a more livable outlook. I discovered a real understanding of life, of people, and most importantly, of me. I learned I have limitations—and that it's okay.

Alcoholism, the Family Disease (P-4), page 11

In everything I do, I will try to reflect the light and the wisdom that will come to me through my surrender to my Higher Power

The Dilemma of the Alcoholic Marriage (B-4), page 81

Spiritual awakenings can occur even when it appears there will be no possible agreement. When I humbly let go of my will, a solution is revealed. It may not be the answer I was looking for, but it becomes clear that it is the one chosen by a Higher Power.

Reaching for Personal Freedom—Living the Legacies (P-92), page 170

Genuine, healthy love isn't self-destructive. It doesn't diminish us or strip us of our identities, nor does it in any way diminish those we love. Love is nourishing; it allows each of us to be more fully ourselves. The enmeshment that characterizes an alcoholic relationship does just the opposite.

How Al-Anon Works for Families & Friends of Alcoholics (B-22), page 83

Because I have come to believe alcoholism is truly an illness, I do not hate my child when he is sick—just as I did not hate him when he had pneumonia or a heart attack. Because of Al-Anon I have found a freedom I could not have believed possible. I have found serenity, peace of mind, and joy. I do not have to be chained to the despair I once knew. To Parents of Alcoholics (P -16), page 12

Wow, it's already been three months into the New Year. Time does fly when one is busy. Since the transition meeting back in January, I have sent out a "newsletter" to all re-certifying Al-Anon Members Involved in Alateen Service (AMIAS) to let them know that everyone will have to attend a workshop to re-certify. I regret having to let them know that there is no online training manual. This has been an ongoing miscommunication through the past four or five years. So, we have a flutter furry of workshops across our area to get everyone who in interested in re-certifying to a workshop.

Back in January our area was down to two Area Trainers and I put out a call for volunteers to step up to the opportunity to serve in this capacity. I have had three people step up and that will help tremendously. Thank you to the three. My vision is to have a trainer in every district, so if you know an AMIAS who is looking to service beyond the group level, get them in touch with me. I've been doing a lot of internet trolling, seeing how other Areas have been doing AMIAS workshops and have learned a lot.

One thought I have to make re-certifying easier is the attendance to an AMIAS/Group Sponsor meeting at a District meeting as satisfying the re-certification workshop requirements each year. That would require a District Alateen Coordinator (DAC) to facilitate the meeting. Not all Districts have a DAC. My thoughts are the district representative could sign off that a group of AMIAS had a meeting at the District meeting. That might work. I have participated in a few webinars. Good webinar service costs money. So that does not seem to be too good an option. But I'm still searching for an easier way to accomplish re-certification.

I attended Program Of Sponsors Sharing Everything (POSSE) and had a great time and as we had a World Service Office (WSO) person there, learned a few things that are seeds for thought. Our Area does have an Alateen Liaison this year. That's good thing. We have not had one for a few years. It's good that Alateen has a voice and vote at the Area World Service Committee (AWSC).

And we'll be having the Texas East Area 53 Alateen Conference (TEA AC) in April. Hopefully we will have good attendance. I see my work is cut out for me and hope we will continue to have people interested in fostering Alateen in our Area for years to come. Thank you for allowing me to serve.

Greetings to all!

In the case have not already heard, April is Alcohol Awareness month!

According to Claire R. the WSO Associate Director-Professionals,

"The WSO cooperates with national events such as April Alcohol Awareness Month, Recovery Day Canada or September National Recovery Month because these special focuses are opportunities to work together for the common goal of educating the public and helping more families of alcoholics learn about Al-Anon. Members can do this by contacting organizations that are hosting events or accepting invitations from them to provide Al-Anon services such having an Al-Anon information table, providing speakers or presentations during the months that these events take place. Al-Anon members and service arms can also host special open meetings during these timeframes to attract more families of alcoholics as well as to educate the public.

All that Al-Anon hopes to achieve by cooperating with these special events is attract more newcomers to our program by making Al-Anon more visible in communities. Al-Anon is not permanently affiliating with the sponsors of these special events or "promoting" our program. We are only providing information about our program, i.e., attraction. "Cooperation and good will strengthen Public Outreach" as cited in our Service Manual on page 188."

In general, The WSO's website is a great resource for getting ideas and materials for Public Outreach. The member's resource (http://al-anon.org/for-members/members-resources/manuals-and-guidelines/) and the public outreach pages (al-anon.org/for-members/public-outreach), have listings of literature and tips that are helpful in planning Public Outreach activities.

Three suggestions for Alcohol Awareness month:

- Individuals can place Al-Anon Faces Alcoholism 2018 Magazines, (please remember to get permission when leaving magazines at doctors' offices and businesses) Groups can invite professionals to open meetings and or supply members with pamphlets to leave at businesses, offices or mail.
- Districts can send extra PSA's to radio stations and T.V

I look forward to hearing what folks did for Alcohol awareness month from your District POC at our Assembly in May!

**Chairman:** Lynn S. opened the meeting at 2:10 pm followed by the Serenity Prayer, a welcome to the current AWSC, and a thank you to the outgoing and incoming AWSC. The Twelve Concepts of Service and General Warranties of the Conference were read, as well as the purpose of the AWSC on p. 162 of the 2014-2017 Al-Anon/Alateen Service Manual.

Secretary: Paula H. called the roll. Twenty-two of the 28 voting members were present. The following AWSC Coordinators were not in attendance: Public Outreach and Spanish. The following Districts had no representatives in attendance: District One, District Nine, and District Ten. The following Al-Anon Information Services/Literature Distribution Centers (AIS/LDCs) had no liaisons in attendance: Austin, Houston Hispanic, Houston, and South Texas.

Chairman Lynn S. approved the minutes as printed in *The Beacon* (Vol. 50, Issue 1). The chair mentioned that the minutes will be sent by the Secretary to the AWSC prior to publication in *The Beacon*. Corrections to the minutes will be sent to Lynn S. and to Paula H. Responses to receipt of emails are appreciated.

Treasurer: Jennifer S. reported that there is currently \$41,886.81 in the checking account and \$20,311.43 in the Certificate of Deposit (CD). There was a surplus from the Fall Assembly of \$712. All checks have cleared. The books for the past three years were passed to the Audit Committee by the previous Treasurer, and the end of year Treasurer's report will be filed for audit. A contribution form to ETAAA was distributed and is also available on the TX East section of the TX website. An Area Expense Claim Form (also on the TX East section of the TX website) was distributed. Expense forms can either be copied and mailed to Jennifer S., or they can be scanned and sent via email. For travel expenses, please print map directions with the starting and ending point, and submit it with a claim for round trip miles. If a side trip is needed, please put in the explanation on the form. Either gas and/or mileage can be submitted with receipts; actual expense divided out by the number of people in the car can be submitted. District Representatives will submit their mileage to their districts. AWSC incoming and outgoing officers and coordinators will submit their mileage for this AWSC meeting in Gonzales. For reimbursement of other expenses, please put expenses under "Other" and explain.

The deadline for submitting the Area Expense Form for this AWSC meeting is  ${\bf March~31}$ .

Area Delegate Report: Kay C. expressed gratitude for service and spiritual growth and excitement about attending her first World Service Conference in April, 2018 in New York. The Conference theme is "Al-Anon—There is no standing still!". Cards and love gifts can be mailed to Kay at the hotel address listed in *The Beacon*, (Vol. 50, Issue 1, p. 13). Kay sent a Delegate's update to the AWSC on January 13, 2018. Included in the update were the Chosen Agenda Items, information regarding the 2018-2021 Al-Anon/Alateen Service Manual, the South Central Region Delegates' Meeting, the Al-Anon Membership Survey, service opportunities at the World Service

Office (WSO) level, ATAAC, and the International Al-Anon Convention, July 6-8, 2018 in Baltimore, MD. Kay has resume forms for the service opportunities at the WSO level, and the resumes are due by **August 15, 2018**. Kay also mentioned that everyone has access to "AFG Connects" if WSO has your correct contact information; questions and feedback can be posted on that site. #### **Unfinished Business:**

Update on Realignment of Districts 4, 5, and 7:
 Mattie T. mentioned that in addition to the report in The Beacon, more discussion needs to take place. Resulting items for consideration from the Task Force on Realignment of Districts 4, 5, and 7 are as follows: 1. 5 Groups from the Bay Area Club in League City, TX, want to move from District 5 to District 4; 2. 4 Groups in The Woodlands want to move to District 7, but there are 11 Groups in The Woodlands; 3. Do we want to move forward with the realignment of Districts 4, 5, and 7? After much dis-

cussion, Lynn S. dissolved the Task Force and made the following recommendation: new District Representatives from Districts 4, 5, and 7 will contact groups to see if they would like to move or remain the same. Then a recommendation will be brought to the AWSC meeting in August, 2018, and it will be presented for a vote at the November 2018 East Texas Area Assembly in Longview, TX. #### ASSEMBLY MENTOR TASK FORCE

In May, 2017, the Area approved a motion to create a position of Assembly Liaison for a three year trial period to be voted on by the GRs at the May 2018 Area Assembly. The position will provide continuity between Spring and Fall Assemblies and serve as a mentor to the Area Host Committee(s) District Representative(s) by answering questions, clarifying procedures, and securing additional assistance if needed based on their experience.

A Task Force was formed to draft a proposal to develop responsibilities and role, qualifications, and selection, term, and funding of the position. During draft review and discussion at two subsequent AWSC meetings, the AWSC consensus was to change the position name to Assembly Mentor (formerly Assembly Liaison).

This draft is for GRs to review prior to presentation at the May 5, 2018 Assembly business meeting.

Assembly Mentor (Liaison) Task Force Joyce Y. - Chair Kay C. Debby C.

#### A. Responsibilities

The responsibility of the Assembly Mentor would be to provide continuity between the Spring and Fall Assemblies and be a mentor to the Area Host Committee(s) District Representative(s) (DRs).

#### B. Role

- To contact each DR of the upcoming Assembly (e.g., Spring and/or Fall Assembly Host Committee DR(s)) and schedule a meeting and/or conference call to discuss the Assembly Guidelines and the time-line of the Assembly (e.g., venue selection, flyers, speakers, etc.). Depending on the District where the Assembly is held, this may be 2 years before the Assembly occurs.
- To keep in contact with the Area Host Committee DR(s).
   The Assembly Mentor may consider attending the first Area Host Committee planning meeting. If the Assembly Mentor does not live in the Area, use of conference or video calling is suggested.
- 3. To keep the Assembly reports prepared by the Area Host Committee after the Assembly. It is suggested that: 1) the reports be organized by Area Host Committees (i.e., Districts) with a cross-reference to Assembly Date and Area Host Committee; and 2) hard copy/electronic copy be kept by the Assembly Mentor and/or an additional electronic copy under Texas East Members Section of the Texas website.
- To provide guidance and experience to the DR and the Area Host Committee.
- 5. To be in regular contact with the Area Chair.

#### C. Qualifications

- Have experience in chairing or planning an assembly or an Al-Anon Conventions (e.g., All Texas Al-Anon/ Alateen Conference).
- 2. Must be an active participant in regular local Al-Anon meetings.
- Must be able and willing to work within the ETAAA Assembly Guidelines.
- Must be responsible and have ability to complete projects.
- 5. Must be willing to be available when needed.
- Must be willing to serve and attend Assembly Host Committee planning meetings, Assemblies, and optional AWSC meetings.
- 7. Must be willing to serve a 3-year term.

#### Selection, Term, and Funding of Assembly Mentor

The Assembly Mentor should be selected by the Area Chair with input from the AWSC and the DRs that are responsible for the upcoming and future assemblies. Location of the Assemblies should be taken into consideration. The term of the Assembly Mentor would be 3 years starting after the Spring Assembly of the newly elected panel of ETAAA officers and coordinators. This would promote continuity and help transition for the Spring assembly chaired by a new DR. Any funding for the Assembly Mentor is to be discussed by the Assembly Mentor and the Assembly Host Committee.


