<u>summary</u>/. You can also purchase a copy from the World Service Office (WSO). Below are some of the items I covered in case you weren't able attend or just want a review of what was presented.

Finances. I want to thank all of you who contribute to WSO. WSO still depends on Literature sales in addition to contributions to help support the services they provide to every group, whether or not that group sends a donation to WSO. Currently, WSO spends about \$292.00 on every group. It is impossible for all groups in our Area to donate that much money to WSO so it is suggested that if every registered group donated an additional \$8.00 per group to WSO, we would be closer to reaching our budgeted contribution goal of \$2,050,000.00. Groups that already make regular donations could add \$8.00 to their contributions. Groups that currently are not sending a contribution to WSO donate could send \$8.00. Every contribution sent by member, group, District and Area is a reflection of gratitude for everything the program has provided all of us. Trilingual WSC. This was the first time that the WSC was trilingual having French and Spanish translators available during the conference. This allowed non-English speaking Delegates to attend. There were some growing pains - like learning to talk at 2/3 speed. However, this did not limit our productivity and honored the spiritual principals of inclusion and participation.

Core Purpose, Mission and Strategic Goals. During the Conference, the Board of Trustees (BOT) unveiled WSO's Core Purpose, Mission Statement and Strategic Goals. These were developed using the framework of our Three Legacies and are used to assist the WSO personnel their work on behalf of Al-Anon Family Groups. In a sharing published in the March 1989 issue of *The Forum*, Hildegard V., past *Forum* Editor, describes her first meeting with Lois W., Al-**Anon's Cofounder, and the** ensuing friendship between the two of them.

#### Information from WSO - Discontinued Literature

1. It was brought to the attention of the Executive Committee that we were currently circulating two pieces of Al-Anon literature which are not appropriate for today's use. Following complaints coming into the World Service Office from both professionals and from members, which had the potential to open Al-Anon to public controversy, a review was done and the decision was made to bring Al-Anon Welcomes Gays and Lesbians (S-70) and If Your Parents Drink Too Much (P-22) to the attention of the Executive Committee. The Executive Committee, acting in its role as custodian and guarantor of good management of Al-Anon's World Service Office, as assigned by the Board of Trustees, took the following action at its May 21, 2019 meeting:

MOTION was made, seconded, and carried to cease selling and discontinue *AI-Anon Welcomes Gays and Lesbians* (S-70) immediately, to advise the Literature Distribution Centers to do the same, and to prioritize creation of a new service tool reflective in content of the current definition of the "LGBTQ" communities.

MOTION was made, seconded, and carried to discontinue publication and distribution of the piece of Conference Approved Literature *If Your Parents Drink Too Much* (P-22) effective May 21, 2019 and to advise the Literature Distribution Centers to do the same.

2. The 2018-2020 Service Manuals Version (P24-27) are expected to be released November 25th in all three languages. More information about the release date will be sent closer to the release date.

#### Area Alateen Coordinator-Jayne G.~

Greetings to All,

We have wrapped up the re-certification cycle for 2019. We have had a few more people who chose not to re-certify as well as a few Alateen meetings that sent in their GR-3 to inactivate their Alateen meetings.

In spite of the dropping attendance in Alateen meetings, we still have people who are stepping up to the plate to becoming AMIASs (Al-Anon Members Involved in Alateen Service) in hopes of starting Alateen meetings.

We have the new Assembly and WSO approved application on the Texas website and if you're curious, you can take a look and see if maybe you might be interested in becoming an AMIAS and getting an Alateen meeting going in your district. District 8 will be giving it a shot. Woo Hoo!!

In case you missed the news, the Area Alateen Coordinator budget was increased at the past November Assembly. It was my feeling that our trainers are called Area Trainers and the largest expense right now for districts having workshops has been travel. Travel expenses will now be paid through the AAC budget.

The Re-certification workshops were well received and I even had a comment that it was so much fun to sit with many other AMIASs and Group Sponsors and talk about issues and ideas. This is what I had been hoping for with face to face recertification workshops. Dialogue and the sharing of Experience, Strength and Hope for Alateen.

My goal of getting more trainers is starting to fill out. We have one new trainer who took on the responsibility of facilitating re-certification workshops and I am grateful. He will be doing an Initial Certification Workshop at the end of July. I hope we don't scare him away.

We still do NOT have a District Alateen Coordinator (DAC) in every district and that will be the next goal to achieve. Of the ten districts in our Area, we have four DACs. This position is an important Link of our Service structure. If you are curious, I will be happy to talk and answer questions if you are interested in this service opportunity.

I'm very grateful for our web master as she has been willing to work with me to separate the AMIAS information and paper works on a separate tab on the site. Check it out!!

And now, for a rash of Initial Certification Workshops. And looking forward to POSSE in March!!

#### Area Alateen Process Person-Brenda H.~

One of the requirements to serve as an AI-Anon Member In Alateen Service (AMIAS) is to attend an AI-Anon group on a regular basis. Because the Alateen group I give service to meets at the same time as my "home" group, I've been given the opportunity to explore other meetings.

Attendance at meetings is an important part of recovery from the family illness of alcoholism. While Alateen meetings cover the same steps, traditions, and concepts, these meetings are operated by teenagers for themselves. The adults are there to serve as a resource. The Alateen meetings are not a substitute for an adult's own attendance at an Al-Anon meeting.

Since exploring other meetings, I've widened my fellowship and have developed relationships with others throughout my district who offer me a fresh perspective for sharing Experience, Strength and Hope. This has rejuvenated my program and given another depth of understanding in how I have been affected by this illness and how I can recover from it. And, of course, hearing the Experience, Strength and Hope from the teens in the Alateen group have been helpful, too. Our teenagers are a strong group of people. Adults serving as an AMIAS offer a place of support for Alateens to light the way to serenity and hope.

This year's recertification period ended with 65 completing all requirements to be eligible to serve as an Al-Anon member. About 1/3 of the eligible volunteers, chose not to re-submit paperwork. These members will be receiving notification about the steps to take to become eligible again should they choose to do so.

If you have an AMIAS new to your local Al-Anon group because they are searching out a meeting to regularly attend, please make sure to thank them for their service! Who knows, they might inspire you to become an AMIAS.

#### **District Reports**

#### District 1-Mandy T.~

District 1 with Co-Host District 2 hosted the Spring Assembly and we are happy to report that we will be sending a check for \$6,509.64 (includes seed money). I will provide a full report as soon as it is finalized. I want to thank Ginny McCluskey and District 2 as well as the District 1 Committee and members who stepped up to help with the Assembly work. The Spring Assembly could not have been a success without their hard work and support. Thank you to all (130) who attended.

This summer, District 1 recertified three AMIAS. I would like to thank Jayne G. for traveling to Corpus Christi for the recertification training. I would also like to thank Ginny M. (District 2) for hosting the workshop at her home.

#### District 2-Ginny M.~

Our last District meeting was held April 13, 2019. District 2 has a total of 18 Al-Anon groups and two Alateen groups. Twelve GRs were present, and three Al-Anon groups currently do not have an active GR. We did have two visitors from Grupo Libertad, Laredo, Erica G. and Destine H. Our checking account balance at the time was \$2,447. There was discussion about changing the district's bank account at Value Bank to perhaps Prosperity Bank after learning we will be charged fees for not keeping a minimum balance of \$3500. A new District meeting schedule was handed out. We also sent a copy to Dorie J. for the Texas Al-Anon website. We discussed District assistance for four Alateen Sponsors for their expenses in attending POSSE and voted to reimburse each attendee \$50. The Alateen meetings continue to struggle with attendance. Alateen Coordinator Kelly H. is continuing to plan for school presentations and has trained several Al-Anon members to participate. Plans are underway for a Day in Al-Anon to be held in September. Several groups are currently working on developing safety guidelines as suggested by WSO. The district needs to fill service positions for public outreach and literature.

District 2 provided eight gift baskets and two wreaths, along with bookmarks and snacks for the hospitality room at the ETAAA Spring Assembly in McAllen. As the co-host, we also helped with various duties on site.

District 2 hosted an AMIAS recertification workshop on May 25, 2019. There were two Alateen sponsors from Corpus Christi and three from the Valley in attendance. As usual, we thank Jayne G. for her expertise as a trainer. We have a total of four Alateen sponsors now in the district.

Our next District meeting will be July 20, 2019.

Greetings, from District 4!

The Bay Area Club Al-Anon groups hosted our June District meeting. We appreciated the opportunity to use their facilities along with access to their well stocked bookstore. Our Public Outreach coordinator continues to actively attend health fares in the counties of our District. We continue to work with our county libraries, adding Al-Anon literature to their circulation and determining how best to distribute outreach materials. We agreed to explore the possibility of utilizing a conference call option for district meetings for those that can't attend in person but who would still like to participate.

We continue to use our district newsletter, *The Light*, to distribute our district meeting minutes, event flyers and other important Al-Anon information that we want disseminated to our groups.

Our District 4 fundraiser, A Day in Al-Anon, is scheduled for Saturday, July 27, at Alvin Taylor Street. Kay C, our Area Delegate, will be our speaker. Rehearsals are already starting for the skit, all written and directed by our own District 4 creative screenplay writers and producers. We are planning for Spanish translation. The flyer is posted on both the Texas East and Houston Al-Anon websites. We will be using Square to process credit card payments for both registration and literature purchases the day of the event. Please plan to join us.

We're looking forward to assisting District 3 with the Fall Assembly, in Victoria, TX, just south of Houston off of Hwy 59. As a reminder, we'd ask groups to bring baskets for a raffle in support of the Assembly and to help offset the cost of putting this event on. District 3 has a great program planned, so mark your calendars and plan to attend.

# <u>No Report</u>

#### District 6-Judy W.~

Our district is very busy with many trusted servants stepping up to help on various teams. Since the last quarterly district meeting in April, other activity updates include:

Exploring Creation of New District Domain - Several sub team district members spoke with a web design consultant on considerations to create a separate District 6 domain. The District's desired centralized information content goals and current processes were reviewed. Before decisions are taken to the GRs for vote, more information is needed from the Texas website on their current domain cost, processes, and preferred domain software / hosting services; same info has already been received for Austin Information Center. All sub team members understood this effort would likely need to be a phased approach with budget and not something that could be performed overnight.

associated budget and not something that could be performed overnight.

District Hosting Checklist -- A checklist to host a district meetings is being created to help Group Representatives (GRs) feel more comfortable in how easy it is to host a district meeting. Quarterly district meetings move throughout the district's boundaries based on a group's willingness to provide a location, workshop, and trusted servants to host throughout the day. Small groups may partner with a supporting group if the primary group is small.

New District Position – Group Records Coordinator -The district has discussed whether they wanted to split or remain together due to size and large geographic area. For now the district (which contains about 80 groups) want to remain together. To allow the DR to perform additional responsibilities, a new position is being proposed in the district to help maintain group records. District 5 (approximately 130 groups) has shared their experience of using a similar district role. This will be a topic for the next District Meeting; July 20.

Unallocated Funds Thought Force -The GRs agreed to proceed with doing "A Day in Al-Anon For Professionals" event before deciding what to do with surplus unallocated funds. Planning for the event is in the early stages.

Alateen School Poster Distribution Task Force -This team is continuing to inventory remaining supplies, identify meetings (including virtual meetings) within the district, and log historical activity/contents over the last 5+ years that may become repeatable processes so that posters may be refreshed within the Independent School Districts as needed.

Spanish Website Thought Force - This team has begun drafting ideas they would like to see on a District Spanish website. The Spanish groups within the district are participating in this effort.

Workshop Format Committee Workgroup - This team has documented workshops in the past using KBDM and also recorded their lessons. They are working with the Texas website to possibly post their experience so that other districts may know of this activity.

Newsletter Processes/Content - After electing a new newsletter editor last meeting, she has ideas to improve content and the data collection timeline on existing processes. This will also be a topic for the GRs to discuss in July.

#### District 7-Allyn D.~

Greetings to fellow members! Here are 7 updates from District 7:

Held our April quarterly meeting in The Woodlands and our June assembly design meeting in Bryan. We met at the alternate MHMRA of Brazos Valley building due to remodeling at the other facility.

Initiated use of a call-in feature (speaker phone). Although not a perfect substitute for attending in person, it was deemed a useful tool to increase outreach/participation.

Voted to pursue a contract with Marriott Spring Hill Suites in Spring, Texas for the 2020 Fall Assembly. Since District 5 is also contracting with that facility for the Spring 2020 assembly, we polled area officers and other members if they would mind coming to the same facility twice in the same year and there seemed to be no concern. We are working with District 5 in the contracting process to try to equalize pricing while keeping the two experiences different.

Developed a theme for the fall assembly of "2020 Vision: Focusing on Recovery."

Assembly fundraisers are underway: 1. fabric book covers for ODAT books. Special orders for other sized books will be taken; 2. Framed Al-Anon slogans and quotes with accompanying illustrations. These will be sold before and at the assembly.

May 4, 2019

Opening: Lynn S. opened the meeting at 9:15 am with a moment of silence followed by the Serenity Prayer. Pat E. read the Twelve Concepts of Service. Lynn S. welcomed Assembly attendees, thanked District 1 for hosting and thanked District 2 for supporting District 1.

**Delegate's Report:** Kay C. thanked Assembly attendees for their service and expressed thanks for the cards and gifts she received while she was attending the World Service Conference (WSC). The theme of the conference was "Action Is Attraction-There Is No Growth in the Comfort Zone." Kay talked about the Strategic Plan of the WSC, gave the annual update from the World Service Office (WSO), and talked about electronic meetings. The WSC Summary will be available in August, 2019 on the WSO member website.

Kay mentioned the 2018 WSO financial report and the WSO 2019 budget. The annual cost for WSO to support each group is \$292. If groups contribute just \$8 more per year to WSO, WSO can meet its 2019 budget.

Kay discussed the motions that were made at the WSC, reports, upcoming events, Chosen Agenda Items, and the new Public Service Announcements (PSAs) that will be released in August, 2019. Kay's entire presentation will be posted on the TX East website under "Delegate's Corner."

Conversation Items: These included discussion of items to be voted on in the Business Meeting and reports from Thought Forces and Work Groups.

- 1. Policies and Procedures Handbook Mattie T. gave a report from the Work Group on the Policies and Procedures Handbook. The committee will meet and decide how best to proceed.
- 2. Area Meeting List Publishing Policy Diane B. gave a report from the Work Group on the Area Meeting List Publishing Policy. The group will devise a list of questions regarding the policy.
- 3. Translation Equipment Myrthala C. gave a report from the Work Group on translation equipment for the Area. The group received quotes on renting equipment for 50 translating devices. Cost of the equipment would be approximately \$875 per Assembly.
- 4. Alateen Member Involved in Alateen Service (AMAIS) Training Manual Jayne G. is compiling a binder for AMIAS trainers for a recertification only workshop.
- 5. Memorial contribution for Bidge B., Past Delegate Pat E. said that Bidge passed away in April, 2019 and contributed the funeral program to Archives. She suggested that a memorial of \$2000 be given to WSO for her service to the Area.
- 6. Regional Trustee Nomination Kay C. mentioned that a South Central Regional Trustee needs to be nominated from our Area. The criteria for being a Trustee were given at the last Assembly in November, 2018 in Longview, TX. Require-

ments for Trustee include being a member in Al-Anon for 10 years, possessing outside business skills, and not being a member of Alcoholics Anonymous (AA). Nominations are due by August 15, 2019.

Meeting adjourned for lunch at 11:50 am.

Business Meeting resumed at 1 pm.

Coordinator reports were given by Mattie T. (Literature), Jayne G. (Area Alateen), Brenda H. (Area Alateen Process Person), Dolores W. (Area Archivist), Al M. (Area Group Records), Rene D. (Newsletter), Lynn B. (Public Outreach), Myrthala C. (Spanish), and Dorie J. (Website). Reports from Coordinators are on file.

Program of Sponsors Sharing Everything (P.O.S.S.E.): Bennie P. did not give a report but mentioned that it would be in *The Beacon*.

Roll Call: 76 voting Group Representatives (GRs) were present and broken down by District as follows: D1 (11), D2 (7), D3 (3), D4 (7), D5 (14), D6 (12), D7 (2), D8 (6), D9 (3), D10 (2), D12 (7), D13 (2).

Voting Procedure: Lynn S. asked the GRs to decide whether to vote by 2/3 vote, which would have been 51, or to vote by simple majority, which would have been 39. It was decided that a simple majority would be used, and the votes would be cast by ballot.

Minutes of the November 3, 2018 Business Meeting published in *The Beacon* (Vol. 51, Issue 1). Lynn S. called for corrections to the minutes for the Business Meeting held at the November 3, 2018 Assembly in Longview, Texas, as printed in *The Beacon* (Vol. 51, Issue 1). No corrections were made. The minutes were approved as printed in *The Beacon*.

Financial Report – Jennifer S. reported that the financial report was current through May 1, 2019. The 2018 Fall Assembly seed money was returned from District 10, and a profit of \$3264.62 was given to the Area. The Area World Service Committee (AWSC) Leadership Conference that was held in Gonzales, TX in March, 2019 was over budget, due to travel expenses for AWSC Officers, Coordinators, DRs, AlS Liaisons, and other members of the AWSC.

The checking account balance was \$35,695.05; the ample reserve was \$20,691.70; P.O.S.S.E. was \$6,280.11; Texas East Area Alateen Conference (TEAAC) was \$5,934.86, although there was no TEAAC in 2019. (There was no written motion; it was oral.)

Failed: 6 For, 65 Against, Abstentions 5

WSO Birthday Basket Total – Jennifer S. reported that a total of \$773 was collected and will be sent to WSO.

#### Assembly Reports:

- 1. District 10 final report for November 2018 Fall Assembly Sheila E. thanked District 9 and Lynn S. for their support and thanked District 8 for providing the literature sales. There were 157 attendees total; 109 pre-registrations, 10 AAs, and 38 onsite Al-Anon registrations. 82 banquet tickets were sold. Seed money of \$3500 was returned and an extra \$3264.62 was returned to the Area.
- 2. District 1 update on current Spring 2019 Assembly Mandy T. reported that 130 registered for the Assembly, and 90 preregistered. She encouraged early registration for the Fall 2019 Assembly. 
