District 4 Minutes

Meeting Began: 9:30 a.m.

Attendees totaled 14; 6 of which were GRs & 2 of which were Alt. GRs

Due to Covid-19 and for the purpose of social distancing this meeting took place via teleconference.

Meeting opened with the Serenity Prayer. Carol then proceeded with doing a roll call of the officers for the District and asked who else was attending. The roll was followed by Carol commenting on meeting etiquette via a teleconference. She also mentioned that she and Renee thought it might be easiest when doing a vote to only ask to hear from those that might oppose. Carol asked if there were any that had opposed this process. No one opposed which considered the process, for this meeting, acceptable. Carol continued to comment that each person should announce their name when speaking to assist in taking minutes.

The meeting continued with the reading of the Traditions, Concepts of Service and Warranties. Carol then mentioned that since the "Ask It Basket" couldn't be passed that anyone having a question could text it to her (she provided her number) so that it could be addressed at the end of the meeting.

Secretary: Renee G. mentioned needing a volunteer for taking the minutes at the next district meeting as she will be unavailable due to travel. She also mentioned that due to her absence that Kim R. would still open the Surfside building for the next planned District meeting in June. Laura B. volunteered to take the minutes during the next meeting.

Renee continued with presenting last District meeting minutes as found in the quarterly edition of *The Light*. She asked if anyone needed them read. Linda F. made a motion to approve the minutes as presented, Kim R. second. Renee asked if there were any objections and there were none. Motion considered passed.

Treasurer- Kim R. presented the Treasurer report as found in *The Light* and asked if there were any questions. Linda F. made a motion to accept the report as submitted. Renee second; Carol asked for opposers and there were none. Motion considered passed.

Alt DR: Sue spoke of encouraging to write in the Cal Corner blog pertaining to *Intimacy in Alcoholic Relationships, Hope and Understanding for Grandparents, In All Our Affairs, and Living Today in Alateen*. Guidelines for submission can be found in the Cal Corner of The WSO website.

Public Outreach – Pam spoke of having a literature table at the SETA Convention that took place in Galveston in January. She stated it was a big success and that having Al-Anon literature available was well received and overall great experience for her. Pam also mentioned having received 200 copies of the 2020 *Al-Anon Faces Alcoholism* and that possibly at the next District meeting we could get the stickers put on the backs. She also mentioned an outreach opportunity that is coming up, April 20th, the Fort Bend Drug Symposium, that she attended last year; however, she has not yet heard back. She stated that if anyone knows of an outreach opportunity to please get with her. Mattie T. mentioned possibly getting the free bookmark that is available for outreach, M76. Pam mentioned that she already had them. Carol took a moment to acknowledge Pam's hard work and let her know how much it is appreciated.

Alateen Coordinator – Jay was absent. Donna B. spoke in his absence and thanked the District for the support and mentioned that the group would like some of the Alateen Dos and Don'ts cards.

Spanish Coordinator: Absent

Intergroup Coordinator: Laura B. mentioned that there are positions coming up on the board and encouraged others to consider service in this area. Information pertaining to these positions can be found on the Houston Intergroup website. She noted the term is for 3 years.

Newsletter – Laura B. stated the next reports to print in the next edition of *The Light* would be May 15th. Carol took a moment to thank Laura again for her service in doing *The Light*

District Representative: Carol encouraged participation in the Spring Assembly taking place in May and encouraged bringing others.

Old Business- Lakeeta spoke for the Abundant Funds Task Force consisting of her, Sue and Pam. She mentioned that she may need to drop off the call after speaking. Lakeeta stated taking the question to the District groups on use of the funds and received seventeen suggestions which included:

Outreach Suggestions:

More outreach brought to colleges

Books for libraries

Purchasing the Forum to provide to local businesses

seeking advertising on local radio stations, newspapers and billboards

A pamphlet that could be provided of all the local meetings for handing out

Pay for mileage to those willing to take information to the counselors in the District 4 school districts

Participate and provide literature during red ribbon week at schools which is a nationwide outreach prevention that almost all schools participate in. Handouts are typical during these events and it was suggested that we could have something for the kids.

A Day In-Alanon with no registration fee

Speaker Event with no charge

District 4 Minutes Continued

Help with mileage and expenses for those that typically do not participate in assembly and other District functions due to lack of funds

Purchase hand sanitizer and Kleenex for groups

Help Alateen groups with literature

Pay for AMIAS participation and registering to attend POSSE

Assist with cost for needed repairs of District groups buildings; small repairs such as light fixtures and door handles to show an appreciation to those that own the building for allowing the meetings.

Sue with the task force added having the Forum to handout at family day in rehabs.

Pam brought up the use of the form used by District 5 groups to request funds for their needs with the District. She mentioned that there would need to be a way to evaluate such request and how would the District choose what type of expenses would be paid or not paid.

Pam mentioned her group having to address liability insurance. She spoke with an area in Northern California that has over 900 groups, 100 of which require such insurance. This cost the area around \$2,600 a year. Pam's small group of around 12 is having to pay over \$735 a year.

Mattie T. spoke stating that as a District we do not always have abundant funds every year and that funds should be used for the District as a whole. When her group needs more funds, they typically send the basket around again. She also stated some suggestions made for abundant funds are outside issues.

Linda F. asked Pam who is requiring her group to have liability insurance. Pam explained that it's being requested by the church where the meeting is held due to a lawsuit brought, because of a fall from a broken chair.

Pam mentioned a form G41, Reserve Fund Guidelines, which has reserved funds listed which contains questions for the District to consider. Guidelines may also be found in The Service Manual on pages 213 – 214.

Linda spoke to the abundance of the funds existing for some time now and being a non-profit it continues to be a concern pertaining to the IRS as a non-profit organization. Linda asked who suggestions could be made pertaining to the use of abundance funds. It was answered that the contact is Lakeeta. Mattie concluded with a suggestion to send additional funds to the WSO and increasing the budget for outreach.

A Day in Al-anon: Sue stated that A Day in Al-Anon is set for July 25th to be held at Taylor Street Club. The theme is Al-Anon Solutions in All Our Affairs centered around the use of the book, *In All Our Affairs*. Cost will be \$10 for early registration and \$15 at the door. She reported that the day will consist of workshops, an AA Speaker, skit, bake sale and silent auction and taco salad for lunch. Margaret F. is doing the flyer. She sent one to Sue, however it was incorrect. Carol mentioned still having a literature table. Linda F. confirmed that she has secured an AA Speaker, Brad B. with Surfside AFG. Carol mentioned encouraging groups to bring items for the bake sale and silent auction items. Pam mentioned we will be giving away Just for Today and Just for Tonight book-marks.

Carol mentioned that the District meeting scheduled for Sept. 12th in Missouri City will need to be rescheduled due to a conflict with the AWSC meeting. The new date is set for Sept. 19th at 1:00 pm hosted by the Courage to Change AFG. Carol mentioned this is a voting meeting as it is the end of term for current seated Chair positions.

NewBusiness:

New Budget: Kim R. suggested increasing our donations of \$75 to \$100 for each of the service arms. Carol asked if any of the chairs felt their budgets needed to be increased. Mattie suggested the DR budget be increased. Discussions took place on suggested budget increases and changes. Linda commented on the need to turn expenses in a timely manner. It was mentioned this was discussed in past meetings. Renee will review past meeting minutes and provide her findings to the District at the next meeting.

Kim reviewed the requested changes to the budgets: Alateen Coordinator will be increased to \$250 and remove travel for other expenses; increase service arms contributions from \$600 annually to \$1200 annually; DR to \$800; increase Outreach to \$1500.

Cindy made a motion to approve the increases to DR, Public Outreach, POSSE, and service arms, Linda F. second. Carol asked if there were any objections and there were none. Motion considered passed.

Carol spoke on elections pertaining to the area. The Area elects for different chairs and coordinators. She mentioned that it helps for the District to hold elections prior to the election held by the Area in November as well as the groups holding their elections. She asked if the District agreed to hold District elections in September. She wanted to encourage those in the groups to consider holding elections prior to the District election in September.

Alateen Coordinator – Carol announced that Jay is going to have to step down effective immediately as the Alateen Coordinator. Donna was asked if she would be willing to stand for the position. She stated, although not willing to commit today, she would consider.

Love Gifts: Carol mentioned that the AWSO meeting is planned for April 20th-24th and that love gifts can be mailed after April 14th. There was discussion as to what the District would like to do for a love gift. After much discussion, a decision to have koozies made was the consensus.

Linda F. made a motion that District 4 approve no more than \$200 for love gifts for the AWSO 2020. Cindy second. Carol asked if there were any objections, there were none. Motion passed.

Linda and Renee will order love gifts and order 100.
