

#### Delegate Report ~ Mattie T.

Greetings from your Delegate for WSC Panel 61! Life is a roller coaster for me, but God has made me strong enough to enjoy the ride for all the extra activities and Service to the Area.

I attended the South Central Delegate Meeting on March 6-7, 2021 and it was amazing to be able to attend as a first time Delegate representing Texas East Ares 53. To participate and give voice and vote has helped to prepare me for the upcoming WSC, which will be held virtually April 11-16, 2021. I do appreciate all the love gifts I have received from the groups, individuals, and districts.

Becoming a Delegate has been a growth experience for me. #### **Director of Programs Job Posting**

Similarly, at the World Service Office, three Departments are vital to achieving Al-Anon Family Group Headquarters, Inc.'s (AFG, Inc.) Mission to help the friends and families of alcoholics connect and support each other through meetings, information, and shared experiences.

And ... the Department most directly responsible for interacting with members and groups within the WSC Structure and groups and structures across the globe is looking for a new Director of Programs beginning September 2021. The Director of Programs position is essential to ensuring our Core Value-Spiritually based: adhering to our Legacies-is achieved within the WSO and encouraged and supported throughout the fellowship. Roles and responsibilities include development, participation, and execution of Strategic Plan Strategies; leadership of Department Staff and programs including literature, group and international services, and Conference; and application of spiritual principles and policies in procedures and communications.

To fill this role, we are seeking an individual who has been an active member of Al-Anon for at least the last seven to ten years and has served above the group level. We are excited to work with someone who is passionate about managing, developing, and motivating teams and individuals. We are eager to learn from the successful candidate's professional and leadership knowledge and experience. #### **Area Meeting List Publishing**

There has been quite a bit of discussion regarding Area Meeting List Publishing and many have assumed that WSO has a policy. I just want to share some info with you from WSO regarding the Area Meeting List Publishing. I have put in "Bold lettering the direct quote from WSO". I hope that answers a lot of the questions.

"We would like to take this opportunity to reiterate the WSO does not require Areas to form a Meeting List Publishing Policy. The decision to create an MLPP is within the autonomy of each Area. We invite any Area considering whether to develop a Meeting List Publishing Policy to evaluate whether the Area needs such a policy. Has the Area been experiencing significant, ongoing group(s) violations of Al-Anon's Traditions that warrants taking the weighty action of not publishing a group's meeting information in order to protect our members and potential members from finding and attending that meeting?

If the Area decides it does need to create a MLPP, we encourage its Area World Service Conference and Assembly to engage in the very important, thoughtful, principle-based conversations necessary to develop a policy that suits the individual needs of the Area. A policy that answers the questions: How does our Area want to support our groups in understanding and adhering to Al-Anon's principles and three Legacies? What does our Area want for our members and potential members?"

#### Road Trip! You and Your Board Connect

Last year the 'Road Trip! You and Your Board Connect' event had to be postponed. This year the 'Road Trip! You and Your Board Connect' event is planned to be held on October 23, 2021 in Cleveland, OH! Mark your calendars and come and join the Board of Trustees and the Executive Committee members for a day of fun and connecting with each other. At the 2021 WSC, information will be presented regarding the 2021 Road Trip! along with information about how your Area can apply to host the 2022 Road Trip! We look forward to meeting you in Cleveland.

#### **Electronic Meeting Work Group (EMWG) Update**

The EMWG reported to the Board its continuing work on ways to incorporate electronic meetings as groups into the service structure. Any recommended changes will be presented at the 2021 WSC for consideration. Stay tuned for more information following the 2021 WSC.

#### **Contributions and Self-Supporting**

Al-Anon's Tradition Seven — "Every group ought to be fully self-supporting, declining outside contributions."

While contributions cover each group's rent and other expenses, the Seventh Tradition is essential at every level of Al-Anon service. It is both a privilege and a responsibility for groups and members to ensure that not only their group, but all service levels remain self-supporting. This keeps Al-Anon free of outside influences that might divert us from our primary purpose of supporting families and friends of alcoholics.

In keeping with Al-Anon's Tradition Seven, Al-Anon is selfsupporting, accepting contributions only from Al-Anon members and declining outside contributions.

It is very humbling to be the voice of the members of Texas East Area 53. I truly thank all of you who send me comments about the Area and/or Al-Anon as a whole. In closing, I would like to thank you for letting me serve as your Delegate.

#### Alternate Delegate ~ Lynn S.

The most important piece of Conference Approved Literature (CAL) for "how to" in my service to my group, district or area I turn to the current issue of the *Al-Anon/Alateen Service Manual (P24-27)*. As I began the service position of Alternate Delegate to Texas East Area, I turned to the job description for the Alternate Delegate in the Service Manual version two (2) page 137.

Terms Used in Al-Anon Service - "Alternate An eligible member elected or appointed who can temporarily step in and/or complete the service term of a person unable to do so. Some examples of this service role are Alternate Group Representative, Alternate District Representative, and Alternate Delegate."

Continuing on to page 148

"The Alternate Delegate works along with the Delegate as much as possible in communicating with the groups. He acquaints himself with all the Delegate's duties, so that if the Delegate is unable to finish his three-year term, the Alternate can step in to complete it."

The first item of responsibility is to attend the Annual South Central Regional Delegates (SCRDM) meeting March 5-6, 2021. The meeting was to be held in Louisiana but with the many restrictions due to the Pandemic the meeting was held virtually. The purpose of the meeting is to help our Delegate prepare for the World Service Conference (WSC) in April. I am grateful that the Texas East Area is willing and able to provide for both the Delegate and Alternate Delegate to attend this meeting as it is very helpful for both of us.

In Texas East Area 53 the job description for Alternate Delegate includes: Area Literature Coordinator, *The Forum* Coordinator and facilitating the Group Representatives Orientation/ Interchange at the Area Assembly meetings. In speaking with the past Alternate Delegate about these very important duties I decided I would separate these into four areas of information for the Area. I have asked the Area Web Coordinator to help me with a separate post on the website for Literature and The Forum. I hope you will pass the information on to your groups.

My next step will be to review the current website posting of the Assembly Group Representative (GR) Packet for necessary updates for the virtual Area Assembly meeting May 14, 15, 2021. It is with love and gratitude that I serve Al-Anon and Alateen, Lynn.

#### The Forum ~ Lynn S.

The Forum magazine is a monthly publication that represents "The Voice of the Fellowship" by the individual members and groups of Al-Anon and Alateen. Letters and articles are sent from all over the world to the World Service Office (WSO). These sharings offer meeting ideas and materials for use in group discussions.

"The Forum can be used, and is encouraged to be used, by all members and groups for meetings. The Forum, as a concept, is Conference Approved, but it is not possible for each issue to follow the full procedure for Conference Approved Literature (CAL). Sharings received for The Forum are reviewed for their fidelity to the Al-Anon program and principles by a volunteer committee and/or The Forum staff. Time-sensitive articles, such as editorials, interviews, "Inside Al-Anon," section etc.,

The Forum is available by subscription and I encourage each group to subscribe to at least one copy. The cost is \$11.00 for twelve 12 issues. The Forum subscription form is available on the Texas East website as a download or a link to WSO.

#### Literature ~ Lynn S.

From AFG Connects – Literature Coordinators regarding the forthcoming electronic version of the Al-Anon Newcomer Packet (K-10). As was mentioned in the most recent Chairperson of the Board letter, the project was approved for development, and Staff is implementing a previous Literature Committee recommendation to eliminate duplication of information in the Packet. No release date has been set yet, but the project is in progress. It is expected to be available through a variety of vendors, just as our current eBooks are, such as the electronic versions of How Al-Anon Works (eB-22), Courage to Change (eB-16), Hope for Today (eB-27), etc., and it should work in the same way that the eBooks do.

Announcements will be made when it is available. In the meantime, last year the WSO developed a URL that electronic meetings can provide to newcomers so they can sign up to receive an email with newcomer information: Al-Anon.org/welcome. The newcomer will be prompted to enter a personal email address to where the digital information will be immediately delivered. Members may wish to share this in their meetings and include it in their meeting formats when welcoming new members.

Chairperson: Paula H. opened the meeting at 9:08 am with the Serenity Prayer and a personal sharing.

Welcome and Introductions: Paula H. opened the meeting with a welcome to the new panel, Panel 61.

Reading of the Concepts of Service and General Warranties of the Conference: Nina W. read the Twelve Traditions. Everica read the Twelve Concepts of Service and General Warranties in Spanish. Paula H. then read the Primary Function on page 155 of the 2018-2021 Al-Anon/Alateen Service Manual, (Vol. 2).

#### **Secretary:**

Jennifer S. called the roll, and 25 out of 25 voting members were present.

The minutes of the November 6, 2020 AWSC meeting were approved as printed in *The Beacon (Vol. 52, Issue 4)*.

#### **Delegate Report:**

Mattie T. shared her edited report. She reported that a refund of the equalized expenses from the 2020 World Service Conference (WSC) would be returned to the Area for the amount of \$1517.21. She asked Paula to put an item on the Assembly Agenda asking Group Representatives (GRs) to decide what to do with the refunded money.

#### **Alternate Delegate:**

Lynn S. reported that the electronic Newcomer Packet has no release date yet but is expected sometime this year. The new daily reader will be available at the 2023 Al-Anon/Alateen International Convention in Albuquerque, NM.

#### **Treasurer:**

Myrthala C. reported our CD balance is 20,045.32 and our checking account balance is \$41,489.55 and there was \$616.81 in contributions. She shared that District 7 returned the seed money of \$3500 from the Fall Assembly 2020 plus an additional \$768.34. She reminded everyone to use the new Area Treasurer's P.O. Box address. The updated Expense Claim and Donation Forms are now on the Texas Al-Anon website. Myrthala would like expense claims submitted within 2 weeks of an event.

#### Reports:

- 1. Spring Assembly 2021 DebiSu Y. said that District 9 met and would like to recommend holding a virtual assembly due to the pandemic. Paula H., Area Chair had asked District Representatives (DRs) to poll their GRs in advance of today's meeting as to their preference of the type of Assembly, virtual, in person, or hybrid. ## INFORMATION REGARDING VOTING ITEMS/CONSENT AGENDA

Our next Assembly is May 15, 2021, and it will be hosted virtually by District 9. Many preparations have been and are being made to hold this meeting. Much more information will be sent to the District Representatives (DRs) and to the AWSC in the coming weeks. DRs will be sharing that information with the Groups in their Districts. Right now our Area Website Coordinator, Natanya A., is very busy scheduling virtual meetings in preparation for the Assembly. We will host several training sessions before the Assembly; it is very important that everyone in the Area who is planning to attend the Assembly attend one of those sessions. I would like to express my sincere appreciation to Natanya, to all who are offering tech support, and to District 9 for all the work they have done in order to make this Assembly happen.

There are several items that GRs will be voting on at the May Assembly. So far those items are the equalized expense money that will be reimbursed to the Area, the Assembly Mentor Position, Area Public Outreach Coordinator, and Area Alateen Coordinator. Myrthala C., Area Treasurer, has a written report in The Beacon and on the Texas East website (<a href="www.texas-al-anon.org">www.texas-al-anon.org</a>) regarding the equalized expense. She has done an amazing job, and I thank her for her willingness to serve. However, as with all Area service positions, the position remains open if anyone else would like to serve. A description of that position as well as a resume are posted on the TX East website. We also are in desperate need of an Area Alateen Coordinator, and that job description and resume are also posted on the TX East website.

We will be using a very different type of agenda for the May Assembly, a Consent Based Agenda. The agenda is posted in this edition of *The Beacon* and will be posted on the TX East website. I will be sending a detailed explanation of the agenda to the DRs, which they will share with their Groups. This type of agenda is used by the Board of Trustees and in many other non-profit organizations. The main benefit is that it is a real time saver; other benefits are that when we do finally get to meet in person again, it will free up more time at Assemblies for workshops, speakers, and fellowship. This type of agenda requires advance preparation by Assembly participants; all reports will be posted on the TX East website, and everyone will read all reports in advance of the Assembly.




The room rate is \$84.00 + tax per night and we can sleep up to 4 to a Queen room. The hotel has blocked 10 King and 25 Queen rooms.
