Greetings to TX East Area 53! Fall temperatures are in the air and so are preparations for our first in-person Assembly since November 2019! Many thanks to District 12 for hosting the Assembly on November 12 and 13 in San Marcos, and to District 13 for their support! Flyers in English and Spanish have been sent via District Representatives (DRs) to the groups, they have been posted on the Texas East website (www.texas-al-anon.org), and are also in this issue of *The Beacon*. I am excited about spending a wonderful weekend in fun, fellowship, and service!

On August 7, 2021, District 6 hosted the Area World Service Committee meeting in Round Rock, TX. It was fantastic to be together in person again. I would like to thank Anna A., DR, Lynn P., Alternate DR, and District 6 for their planning, hosting, financial, and technical support of the AWSC meeting. Several Thought Forces, Task Forces, and Work Groups gave reports, and two of the Task Forces are still in progress. Minutes from the AWSC meeting are in *The Beacon* and on the TX East website.

Now for Fall Assembly news! The November 1 registration/hotel reservation deadline is rapidly approaching. In addition to approving/amending the May 15 Assembly minutes, which are in *The Beacon* and on the TX East website, there are several items that Group Representatives (GRs) will be voting on at the Assembly. GRs will be voting on the updated Area Alateen Safety and Behavioral Requirements (on TX East website); I wrote a separate Alateen Reinstatement Task Force report, which is in this newsletter and on the TX East website. Another voting item for GRs is to decide whether to accept Electronic AFG meetings into our Area (reports from the Electronic Work Group are in the newsletter and on the TX East website). GRs will also be voting on the 2022 Area Budget.

There is one other voting item for the November Assembly. Our Area Secretary, Jennifer S., is moving out of state, so the Area will need a new Secretary--but she will be present at the Fall Assembly. Jennifer has held various service positions in TX East, and I would like to thank her for all she has done in her groups, in District 8, and as Area Treasurer and Area Secretary. Jennifer, you will be sorely missed! A list of eligible candidates for Secretary has been sent to DRs for distribution to the groups. The secretary's job description and resume forms are posted on the TX East website. Candidates' resumes will also be posted on the TX East website.

I look forward to seeing everyone in November! I sure have missed those wonderful Al-Anon hugs and can't wait to get and give them soon!



Delegate Report ~ Mattie T.

Hello Texas East, I am so excited about our Texas East celebration of WSO's 70th Birthday Anniversary. We are celebrating by having all living past delegates share their excitement of service during their panel year. We have an exciting PowerPoint to share and hope to see you there. But in case you missed it, we will have it become a part of the Texas East Archives.

2022 CONFERENCE THEME:

2022 World Service Conference as: Enhancing Our Recovery through Abundance, Unity, and Understanding. We look forward to seeing how you incorporate and use this theme in the coming year. 2022 WSC dates are April 26 – 30, Westchester Marriott in Tarrytown, New York

ROAD TRIP CANCELLED:

The Board of Trustees recently held a Special Board meeting. The purpose of the meeting was to discuss the October 2021 in person Road Trip! event scheduled to be held in Cleveland, OH.

The Board thoughtfully reviewed current CDC Guidelines for organizations planning large events and considered impacts on both the Road Trip! experience and the safety of members, WSO Volunteers, and Staff. Board members invited our collective Higher Powers into the discussion as well as the decision. The decision made by the Board was to postpone the in person 2021 Road Trip!

The Board is continuing conversations regarding Road Trip! We realize members may have many questions, including how refunds will be handled. We ask that you hold these questions until further updates become available, which should be within the next week or two.

On behalf of the Board of Trustees, Executive Committee, and the WSO, thank you for your patience and understanding as we move through our ever-changing world.

FINANCE:

While 2020 was a record year for contributions, we know that many groups meeting temporarily online are just now deciding whether to return to face-to-face and group expenses are increasing to cover rent and other costs that did not exist in the virtual world. Sadly, we concluded we needed to reduce our contributions budget. Some good news is that literature orders were higher in the first half of the year than expected and we see some LDCs reopening and/or reordering literature. Unfortunately, we expect an increased deficit budget of \$(233,753). As we continue "Moving Forward with Unity, Courage, and Perseverance" and reestablishing budgets at all levels including our groups, we remember that "Together We Can Make It!" We thank you in advance for your ongoing support through contributions and literature purchases!

POLICY COMMITTEE TASK FORCE:

A new Task Force, Public Outreach in Relation to Social Me-

dia, brought an interesting discussion forward, reflecting on the term "local," especially in this age of globalization. We look forward to this group bringing back additional thoughts, questions, and insights to the October Policy Committee for another thought provoking conversation.

Two other Policy Task Forces, Announcing Events and Local Services, have continued to meet and to offer updates to the Policy Committee. More detailed information will follow after the October Policy Committee Meeting.

NEW PSA:

WSO recently launched the new PSA, and they began playing in stations in early August to positive reviews. They have received several requests for the PSAs so they can be posted on Service Arm websites. We have had Natanya A., our website coordinator, add the PSA to the Texas East website. Feel free to visit the website and view the PSA.

WSO NEW-HIRE - DIRECTOR OF PROGRAMS:

I'm thrilled and delighted to inform you that Sarah Smith, currently of Missouri, has accepted the offer to serve as the new Director of Programs at the World Service Office. Sarah originally joined the program as an Alateen and began her service journey at the WSO level as a member of the WSO Alateen Advisory Committee. She has since served as a District Representative, Area Delegate Panel 57, and Area Chair. She is well-respected in her Area as a leader and a member with deep knowledge of and experience with utilizing Al-Anon principles in supporting the fellowship. In her professional career, Sarah has more than 15 years' experience in Operations Management and demonstrated throughout the interview process her leadership and team building skills.

FINANZAS:

Si bien el 2020 fue un año récord para las contribuciones, sabemos que muchos grupos que se reúnen temporalmente en línea ahora están decidiendo si volver a las juntas presenciales y aumentar sus gastos para cubrir el alquiler y otros costos que no existían en el mundo virtual. Lamentablemente, llegamos a la conclusión de que necesitábamos reducir nuestro presupuesto de contribuciones. Una buena noticia es que los pedidos de literatura fueron más altos en la primera mitad del año de lo esperado y vemos que algunos CDL reabren y/o reordenan la literatura. Desafortunadamente, esperamos un aumento del presupuesto del déficit de \$ (233,753). A medida que continuamos "Avanzando

con unidad, valor y perseverancia" y restableciendo presupuestos en todos los niveles, incluidos nuestros grupos, recordamos que "¡Juntos podemos lograrlo!" ¡Les agradecemos de antemano por su apoyo continuo a través de contribuciones y compras de literatura!

As of writing this report, I have opened and examined all of the tubs containing our East Texas Area 53 Archives. I found a wealth of materials that reflected our Area's and Al-Anon's history in general.

Here is a sampling of what I found:

- ❖ Handwritten/typed original minutes books from our early Assemblies
- ❖ The first handmade banner that was displayed at an Area Assembly held in 1977
- ❖ Display of the Alateen groups in attendance at the first E-TAC Conference held in our Area
- ❖ Typed manuscript autographed by Lois Wilson that was the draft of her memoirs of the year-long Motorcycle trip she took with Bill
- Variety of speaker tapes and pictures
- Out-of-print books and pamphlets

The documents and artifacts ranged in quality of how they have survived over the years. Much of the very early archives are in need of protection before they can be displayed.

The slogan *First Things First* kept coming to mind as I rummaged through the tubs. I have decided to start preserving the older items first. As I protect these materials, I hope to be able to share them with our Area.

favorite search engine (like Google, for example), type in "Al-Anon meetings near me," then, when the World Service Office (WSO) search fields come up, use them to find your group.

Make sure your public meeting listing extends a warm hand - with lots of location instructions to visitors and newcomers. Sometimes we regular members take for granted that the room can somehow be found. That is not always the case. Put yourself in their shoes and think about what you might need.

If changes to your listing are needed, or if your Group Representative (GR) and/or Current Mailing Address (CMA) have changed, simply send me an email at grouprecordsarea53@gmail.com. The Area Group Records team, Cathy M., Laurie F., or I will be happy to make the changes!

In another key initiative, I am happy to report that, since districts 4, 5, 6 and 7 are now only using the WSO database to provide meeting information, as opposed to attempting to keep a second list updated and synchronized through the Information Service Offices/Intergroup, we have received a lot fewer "Reported Not Meeting" notices. "Reported Not Meeting" notices happen when the meeting information has not been updated and someone showed up at a non-existent meeting. (Ouch!) With one list to maintain, not only is there less outdated information, overall it is less confusing for everyone, and so much easier to maintain.

<u>Literature Coordinator ~ Lynn S.</u>

The AFG Connects for Area Literature Coordinators posted from Tom C. WSO Associate Director—Literature the following letter. As I read it I thought it was informative and would be of interest to our Area Al-Anon and Alateen members.

Dear Sandra,

Thanks for bringing up the concerns of someone you service sponsor regarding references to God as male in the Twelve Steps for discussion among other Literature Coordinators. I do have some additional information to share that was not mentioned by Coordinators who shared with you that I think might be helpful to know when considering this topic.

The first is the Al-Anon World Service Conference Charter, found on pages 224-5 of the 2018-2021 Al-Anon Alateen Service Manual, version two (2). It states that our three Legacies, the Steps, Traditions, and Concepts of Service, can only be changed by written agreement of three-quarters of all Al-Anon groups. Any decision to attempt such a change has to be agreed to by the Conference. If the Conference should decide to propose a change, a poll would be taken of all groups worldwide. The difficulty of this process is reflective of its importance.

Of course the Steps and Traditions are not the only items in Conference Approved Literature that have references to God as male. In their personal sharings, some members of our inclusive fellowship use the pronouns "Him" or "He," while some use "Her" or "She." Others do not assign a gender to their Higher Power, or use another

term to describe their idea of a Power greater than ourselves. Although stories are often edited for grammar or length, the Literature Committee has repeatedly stressed the need to retain the flavor and ideas expressed by each member. The Literature Committee has concurred in the past that when quoting these sharings, we respect the intent of the members who wrote by preserving their personal interpretations without alteration, unless it advocates a specific religious tenet or philosophy. Specific religious discussions are advised against in the "Three Obstacles to Success in Al-Anon."

In reviewing the descriptive or introductory text of Al-Anon literature, the Literature Committee has given much attention for more than 30 years now to be reflective of our diversity by using gender-neutral references whenever possible in the creation of new literature and in the revision of older materials. In the text of these newer or revised materials, terms such as "God of our understanding, "Higher Power," or "Power greater than ourselves" are used without any gendered reference. Likewise, Al-Anon members and their alcoholic friends and relatives are not assumed to be a particular gender. However, there have been some early pieces, such as The Dilemma of the Alcoholic Marriage (B-4) and One Day at a Time in Al-Anon (B-6) that many members have asked us to not change. These members feel certain pieces, as originally written, are a useful part of our history. They want to be able to avail themselves of the words and insights of our co-founders and pioneer members as originally written. This year's World Service Conference maintained that viewpoint in motions to create new introductions to these books, placing them in historical perspective of the time they were written in, rather than revise or update their wording.

Hello Texas East Area 53. Here's the latest in Public Outreach:

1) WSO has created a beautiful new **Public Service Announcement**! Per WSO: "Al-Anon public service announcements (PSAs) reach hundreds of millions of people every year throughout the US and Canada, thanks to the generous commitment of TV and radio stations to offer free airplay. While the faces and voices featured in the PSAs are those of actors, the scripts are exclusively Al-Anon in content and carry the Al-Anon message of help and hope to the public. Members can participate by sharing the PSAs from YouTube or https://al-anon.org/ to their social media network. Please remember to protect your anonymity on social media by not making comments that would reveal your Al-Anon membership."

Simply sharing/posting without adding a comment that you are a member keeps anonymity, a core principle in our program. To find the video, go to: https://al-anon.org/, hover over "Members" and click on "Public Outreach". Then click on "Public/Media", then "Media Center." At the bottom of the Media Page, click on "Public Service Announcements (PSA)". The "Benefits of Recovery" is the new PSA. Take a minute to check it out. WSO did a fabulous job!

2) In the last issue of the Beacon, the new Al-Anon/Alateen posters were announced. Per WSO: "The Al-Anon and Alateen poster designs have been developed specifically for local public outreach. The poster templates can be downloaded and customized with local contact information. They are available in different designs and orientations (vertical or horizontal) that best fit your project. Other sizes and formats are available. Please email publicoutreach@al-anon.org with your desired format. There is no requirement to submit these posters to the WSO for review as long as no other modifications have been made. As a reminder, please include your Area Public Outreach Coordinator on all your outreach projects."

So where do you find these posters, you ask? Again, go to https://al-anon.org/, hover over "Members", click on Public Outreach Posters, and there they are. You'll see two Al-Anon and three Alateen posters. All are impactful and eye-catching. I love that there's a place for us to put our local information, whether it is contact info for an intergroup, a District, or a group.

3) I've made contact with several District Public Outreach Coordinators in Area 53. They are all eager to reach out to those who have yet to find us and are still suffering. If you hear of an opportunity to bring Al-Anon information to a health fair, a rehab, a school, a therapist, doctor, prison, jail, law enforcement agency, etc., let your District Public Outreach Coordinator and/or District Representative know. More often than not, it is word of mouth that brings outreach opportunities to those who are ready and willing to be of service.

Electronic Meeting Work Group

Summary for Decision on Allowing Exclusively Electronic Al-Anon Family Groups to Participate in Our Area 53 Service Structure

Before Spring 2021, meetings which met exclusively electronically were only considered supplemental to Al-Anon. They were not official "Al-Anon Family Groups" (AFGs), and they were not allowed to register as a group with the World Service Office (WSO). These meetings did not have a GR and did not participate in an Area service structure. What that means is that they were not assigned to a district and were not represented at Area Assemblies.

With the pandemic, the perception of electronic meetings changed significantly to the point where, in April 2021, the Al-Anon World Service Conference (WSC) decided that the exclusively electronic meetings will be Al-Anon Family Groups (AFGs) and put in a virtual area. (Think of this as an area "in the cloud.") Additionally, all newly registered exclusively electronic AFGs would be put in the virtual area. Just like geographic areas, the virtual area will have its own area trusted servants elected by GRs in the virtual area, including an Area Chair

and a Delegate.

With this major change, the question the WSO asked each area to decide is whether exclusively electronic AFGs will be allowed to participate in their geographic area service structure. If so, GRs voting at the area level can decide specifically how that would work. If we don't want exclusive electronic groups to participate in our Area 53 service structure, by default, they will remain part of the virtual area.

At the upcoming fall 2021 Area Assembly, Group Representatives (GRs) will have this important decision to make. The discussion and possible vote will take place at the Assembly that is scheduled for Saturday, November 13, 2021, in San Marcos, Texas.

To assist GRs in making an informed decision, an Electronic Meeting Work Group (EMWG) was formed by Area 53. The EMWG 1) developed a full report on the background including detailed pros and cons, 2) surveyed Area 53 GRs and included their comments in the full report to GRs, 3) received detailed guidance from the Area 53 Chair and Delegate, 4) answered Al-Anon's knowledge-based decision making (KBDM) questions and 5) considered the approaches and actions of other Areas on this matter.

The EMWG found that other Areas are also considering this decision. Pros for allowing exclusively electronic AFGs in Area service include fostering general inclusiveness, plus consideration for engaging younger members who are often very electronically oriented and attracting or at least maintaining a large pool of members from which to have service representatives. Cons include the complexity and potential costs of conducting Assemblies and other Area-related activities. Out of the entire Area, fewer than a dozen GRs and other members responded to the survey. Their responses included both pros and cons.

The EMWG will be presenting the details of its work at the Fall Assembly for discussion and possible vote by GRs on whether exclusively electronic AFGs should be allowed to participate in Area service structure.

TASK FORCE REPORT ON ALATEEN REINSTATEMENT FOR ETAAA 2021

Due to a missed deadline, 51 Al-Anon Members Involved in Alateen Service (AMIASs) and 19 Alateen meetings were inactivated by WSO on July 1. However, we were aware before July 1 that we had missed the WSO deadline of 6/15/21 for recertifying our AMIASs, and steps were immediately put into place to get the AMIASs recertified and to get Alateen reinstated in our Area. I assigned a Task Force (TF) on 6/18 to accomplish this; Mattie T., Lynn S., Jennifer S., Myrthala C., and myself comprise the TF. We reviewed the Alateen Safety and Behavioral Requirements (ASBRs). When the review was completed on 6/24, we asked Jayne G., a former Area 53 Alateen Coordinator, to send the ASBRs to legal counsel for review on 6/25, as this legal counsel had reviewed our ASBRs in the past, and he reviewed them free of charge. When the legal counsel returned the reviewed requirements to us with suggested changes on 7/2, the ASBRs were immediately sent to the World Service Office (WSO) for approval.

On July 13, TX East received approval from WSO of the ASBRs; they recommended adding the following statement to the "Alateen Permission and Medical Forms": "Reviewed June 24, 2021; approved by Legal Counsel July 2, 2021." Those changes were added, and Group Representatives (GRs) will vote on the update ABSRs at the November 2021 Assembly. Mattie received notice from WSO that Alateen has been reinstated in our Area; however, we cannot start Alateen meetings immediately, as there is more to the process.

In order to continue restoring Alateen in our Area, a one-hour training recertification module is to be conducted with our Area AMIASs who had already completed their certification requirements by June 1. Mattie T. asked Lynn S. to develop this module with the materials used in the training workshops. Lynn has been in contact with Sue Perez from WSO regarding the development of the training module to make sure we are meeting the instructions from WSO in order for our Alateen program to be activated ASAP. It was determined that in 4 one-hour sessions with a limited number of participants in each group, the training could be completed within two weeks. It was also determined that it would not be necessary for the AMIASs to submit another background check, as those are valid for one year. Lynn completed the training module, and she presented it to the TF on July 30.

It was determined that each AMIAS would complete the Al-Anon Member Involved in Alateen Service form and mail it to Ilene, our Area Alateen Process Person (AAPP). That would give Ilene a record of who attended the one-hour recertification training sessions. Once Ilene receives the WSO form from each AMIAS she will activate our Alateen meetings. The goal is to do this no later than September 1. An email will be sent to the 51 AMIASs informing the AMIASs of the four (4) training dates with the ASBRs, the Alateen Permission and Medical form, the updated Safety and Behavioral Orientation Training Document and the edited AlAnon Member Involved in Alateen Service form. All of these documents will be discussed in the training.

On August 7, Lynn S. sent an email to all Texas East AMIASs asking them to register for one of the four one-hour training sessions; these training sessions are required by WSO to complete the reinstatement process to activate the Texas East Area Alateen program. There are links and instructions to register for the training sessions; they are August 11 at 7 pm, August 14 at 10 am, August 15 at 4 pm and August 16 at 7 pm. Once the AMIASs are registered for the session they chose, they will receive an email from Natanya A. with the information required to log into the meeting. Further information will follow when the required training is completed and when the paperwork is submitted to WSO.

As of September 1, 2021, forty-seven (47) AMIASs have been recertified and have submitted their paperwork to Ilene F., our AAPP. She sent the required group forms to WSO, and all 47 AMIASs can hold Alateen meetings again. Nineteen Alateen groups can now meet, in addition to a new Alateen group that was added.

At the November 2021 Assembly, GRs will vote on the updated ASBRs, which will be sent to the District Representatives (DRs) for distribution to the GRs. The ASBRs will also be posted in *The Beacon and on the Texas website* (www.texas-al-anon.org).

I would like to thank the members of the Alateen Reinstatement Task Force, Mattie T., Lynn S., Jennifer S., Myrthala C. for their diligence and hard work to make this process happen. (I was also on the Task Force.) My deepest gratitude goes to Lynn S. who so graciously conducted the recertification training in a timely manner and to Natanya A., Website Coordinator, for setting up the Zoom meetings. I also appreciate Carolyn F., our Area Alateen Coordinator (AAC), and Ilene F., our AAPP for all their assistance in getting Alateen reinstated so quickly in Texas East Area 53. Also, I would like to thank the AMIASs who recertified and turned in their forms on time to Ilene. In fact, TX East was the FIRST Area to complete the reinstatement process! Way to go, TX East! This is teamwork in action!

Kay C. read the Twelve Concepts of Service and General Warranties, pp. 17-18 in the 2018-2021 Al-Anon/Alateen Service Manual (Vol.2).

Delegate Report: Texas East Past Delegates will be sharing their experience Saturday, October 2, 2021 from 11 am-3 pm in Missouri City. The World Service Office (WSO) has a new Director of Programs, Sarah. The rest of the report was after lunch so Mattie T. could attend a mandatory Delegate meeting. The theme of the 2022 World Service Conference (WSC) is "Enhancing Our Recovery Through Abundance, Unity and Understanding". The revised WSO budget has a deficit lower than expected due to sales and contributions. If every group could contribute \$263 to WSO it would help get WSO out of deficit.

Secretary: Jennifer S. called the roll, and 19 out of 28 voting members were present. For voting procedures, it was determined that 13 was 2/3 and 10 was a majority. Those absent were Spanish Coordinator, Districts 1, 2, 4, 5,7, and 13, Beaumont AIS Liaison and Houston Hispanic AIS Liaison.

Treasurer: Myrthala C. reported our CD balance is 20,090.01 and our checking account balance is \$41,889.70. She explained that a correction needed to be made to the 2021 Financial Report. An approved item from the November Assembly had not been added to the report. A correction was made by adding line-item Web-Based Conferencing. She also corrected the line-item of Delegate's Incidental Expenses to WSC of \$290.39.

Approval of Consent Agenda: The Treasurer Report and Literature/Forum Report were pulled from the Consent Agenda before it was approved.

Upcoming Assemblies:

- 1. Fall Assembly 2021- Lynn S. (District 12/District 13 Support) reported that the theme for the Assembly is "Removing Our Masks" District 12 is hosting the assembly November 12-13, 2021 in San Marcos. The assembly will be Friday and Saturday only due to a conflict at the hotel.
- 2. Spring Assembly 2022 Ginny M. (District 2/District 1 Support) District 2 will be hosting the assembly May 13-15 in Corpus Christi. It will be held at the Holiday Inn Downtown Marina.
